ber. Brother Ferguson explained individual officer responsibilities and spoke to Chi Upsilon about the requirements needed to become a Chapter. He also met with Dean David L. Shrock and Business Council advisor Ms. Ann Coppennoll Farni. Professional speakers, tours and community service events, along with activities involving other Deltasig chapters, were held throughout the 1991-92

academic year.

The North Central and Midwestern Regions were highly supportive of Chi Upsilon Colony. The "North Central Kick Off Classic," held on September 28, 1991, gave colony members a good indication of the level of brotherhood in Delta Sigma Pi. In attendance was Mid-American Provincial Vice President Randy L. Hultz, Regional Director Mark E. Dorn, District

Director William E. Honan, and several chapters in the region.

Consultant Kathleen Skrobot-Dinius also had the opportunity to visit with the colony in October of 1992. She met individually with all the colony officers, the Dean of the College of Business, and the Colony Advisor Richard B. Carter. She also attended an Executive Committee meeting and a general colony business meeting. At the business meeting, Brother Skrobot-Dinius made a presentation about Delta Sigma Pi to the new recruits and described the upcoming North Central Regional Conference and Grand Chapter Congress. Four members of Chi Upsilon Colony attended the North Central Regional Conference.

A calendar of activities, outlining events planned through April of 1993, and Colony Bylaws were submitted in February 16, 1993. On January 15, 1993, Chi Upsilon's petition for a chapter charter was approved by the Board of Directors.

On the morning of March 27, 1993, representatives from collegiate chapters in the Mid-American Province gathered along with national officers for the installation of Mu Psi Chapter at Iowa State University. Grand President William R. Kinsella, Mid-American Provincial Vice President Randy L. Hultz, North Central Regional Director Mark E. Dorn, District Director NolaKay A. Kelm, Executive Director Michael J. Mazur Jr., and Brothers from Epsilon Chapter at the University of Iowa, Alpha Delta Chapter at the University of Nebraska, Alpha Epsilon Chapter at the University of Minnesota, Alpha Iota Chapter at Drake Univer-

Iowa State University in Ames, Iowa is the home of the 233rd collegiate chapter of Delta Sigma Pi. Mu Psi Chapter, installed on March 27, 1993, is the fourth chapter to be chartered in the state of Iowa, and joins chapters from Nebraska, South Dakota and Minnesota to form the North Central Region of the Mid-American Province of Delta Sigma Pi.

Mu Psi Chapter started as Chi Upsilon Colony in January of 1991 when District Director William E. Honan met with David L. Shrock, the Dean of the College of Business. Dean Shrock made inquiries at the college to determine the level of interest in establishing a chapter of Delta Sigma Pi at Iowa State University. On March 1, 1991, a letter was received from Dean Shrock granting permission to hold informational meetings and recruit students into Delta Sigma Pi. A "Meet the Fraternity" event was conducted by William E. Honan with District Director NolaKay A. Kelm, District Director Krista K. Aberle, Regional Director (then District Director) Mark E. Dorn and Brothers from Alpha Iota and Epsilon Iota Chapters in attendance.

An organizational meeting was held in April to elect the colony officers and choose the colony name of Chi Upsilon. A Letter of Intent was sent to The Central Office on April 25, 1991. Colony officers continued to meet throughout the summer months to plan for the fall, 1991 semester.

During the fall, 1991 semester, Alpha Iota Chapter at Drake University presented a slide show on Delta Sigma Pi to the colony. A Central Office staff visit from Director of Chapter Services C. Dean Ferguson, occurred in Septem-

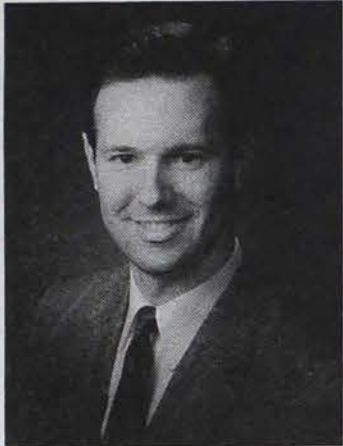

# WELCOME

Welcome to the first issue of The DELTASIG in its new tabloid format. In the process of re-design over the past six months, the publication you now hold in your hands represents the combined efforts of many individuals.

We believe the format change instituted with this issue will make The DELTASIG more attractive, timely, readable, and also less costly to produce. We hope you see the benefits of this change, and we welcome your input and

comments as we progress with our new format.

Just as The DELTASIG has been redesigned this year, so has it gone through numerous changes in style, content and design over the years since it was first published. Beginning in 1907, and for several years thereafter, Delta Sigma Pi was simply a one chapter fraternity with the only record of its activities consisting of the

minutes of its meetings. As the fraternity began to initiate and graduate more men from New York University, the early members of Delta Sigma Pi began writing a confidential newsletter for distribution to them. This confidential newsletter, with existing copies dating back to early 1911, was the fore-runner of The DELTASIG.

In early 1912, the first issues of the fraternity's official publication were published. This publication, which was at first published every other Wednesday, was known as "The DELTYSIG." Later in 1912, the name was changed to "The DELTASIG" and has been the official publication ever since. While The DELTASIG is now published four times a year, in its early years it was not published on a regular basis. In fact, the early editors acknowledged this by heading each copy of the publication with "The DELTASIG, Published Every Once In A while".

Throughout the years, The DELTASIG has chronicled the history of the fraternity and itself. Early highlights included: the first mention of an alumni group, the "Graduate Chapter" (March 7, 1914, issue), the addition of Beta Chapter (June 13, 1914, issue); first mention of the seal of the fraternity, design credited to Harry Cox (September 5, 1916, issue); and the first issue of The DELTASIG printed, rather than mimeographed, on a regular basis (August 28, 1917).

These early highlights and other news and information

were compiled by a number of different editors during the first years of The DELTASIG. The first issues of The DELTASIG were published by editors from Alpha Chapter who were later joined by editors in Chicago (Beta Chapter) and Boston (Gamma Chapter).

For several years this situation worked well until the fraternity experienced a tremendous growth during the years 1920-1924. During this time the fraternity grew from three chapters to 32 under the leadership of Grand President H. G. Wright. It was also during this time at the fifth Congress of Chapters (Grand Chapter Congress) in 1920 that the fraternity saw the need to publish The DELTASIG on a regular basis.

The 1924 Congress of Chapters held in New York City was the meeting in which The Central Office was created as well as the position of Secretary-Treasurer (Executive Director). H.G. Wright was elected unanimously to the position for what was to be a continuous term of 31 years. During this time he became the permanent editor of The DELTASIG, the fraternity's magazine, which had become a quarterly publication. Regular feature articles were instituted along with departments containing chapter and alumni news.

From 1924 until 1942, The DELTASIG had several design changes, but the content remained consistent, including articles of a professional nature, along with fraternity,

chapter and alumni news. In 1942, however, due to the growing number of Deltasigs joining the armed forces during World War II, The DELTASIG again began containing lists of Deltasigs in the armed service as it had before in 1918.

During World War II, only 11 chapters remained active. Along with the decline in the number of active chapters came a decline in income. Because of this decline in income, it was seriously considered that The Central Office cease operations until after the war. It was decided, however, that The Central Office remain open and attempt to provide as many

Grand Secretary-Treasurer, James D. Thompson, who also served as the first Assistant Editor. The DELTASIG resumed publication on a quarterly basis and contained many of the same type of features and departments that appear today.

Since 1946, The DELTASIG has been edited by several editors and assistant or managing editors and there have been several redesigns of The DELTASIG, the last coming in 1987.

Changes have been made in an attempt to make The DELTASIG a more attractive, more readable, professional looking

services as possible, including publication of The DELTASIG. This service was continued until January, 1943, when the majority of Deltasigs were serving in the armed forces making it impossible to maintain enough correct addresses.

After the war, The DELTASIG resumed publication with the November, 1946, issue. By this time, though, the fraternity has also hired an Assistant

publication. The DELTASIG is now mailed to over 36,000 collegiate and alumni members, deans, businesses, libraries and other fraternities in this country and around the world. The DELTASIG is your fraternity's magazine and we want it to contain the types of items you are interested in reading. We hope you enjoy receiving The DELTASIG and reading about Delta Sigma Pi.

sity, Theta Omicron Chapter at St. Ambrose University, and Kappa Upsilon Chapter at Winona State University comprised the installation team for Mu Psi Chapter, which resulted in the initiation of 24 charter members. Golden Council member Norman Kromberg, and District Directors Angela J. Tietz, Shanda R. Gray, and William E. Honan were also present for the installation.

The history of Chi Upsilon Colony was presented by Mu Psi members Christa Lee Catherall, Treasurer; Aimee L. Dunn, Secretary; Joseph G. Mistek, Chapter Member; John H. Newman, Senior Vice President; and Clint R. Smalley, Chancellor. Randy L. Hultz, Mid-American Provincial Vice President, followed up with remarks from the province.

Following the installation of the chapter, a reception and banquet was held at the Memorial Union on the campus of Iowa State University. North Central Regional Director Mark E. Dorn served as Toastmaster for the ceremony. The Invocation was provided by Joseph G. Mistek, Mu Psi Chapter member, and Greetings were extended by Clyde Kenneth Walter, Associate Business Professor at Iowa State University. A history of the College of Business was presented by Mu Psi Faculty Advisor Richard B. Carter.

Iowa State University has offered courses in business since the early 1900's. Before 1984, the College of Business was under the College of Science and Humanities, however on July 1, 1984, it became an independent college on the campus of Iowa State. The College of Business was accredited by the American Assembly of Collegiate Schools of Business in April of 1991. A Bachelor of Business Administration degree is awarded with concentrations in Accounting, Finance, Management, Marketing, and Transportation and Logistics. A Bachelor of Science degree with a major in General Business is also offered. Currently over 3,000 students are enrolled in the College of Business at Iowa State.

Grand President William R. Kinsella then presented the charge and charter to Chapter President Amanda Rae Griest, and Executive Director Michael J. Mazur, Jr. presented Fraternal Greetings from chapters and Brothers across the country.

Iowa State University is a

1,000-acre campus located in Ames, Iowa, a suburban neighborhood 30 miles north of Des Moines. It was founded as Iowa State College on March 22, 1858, to establish a State Agriculture college and model farm. It formally opened on March 17, 1969 as the first co-educational land grant college,

study are available in accounting, business administration, economics, finance, management, and marketing. Mu Omega Historian Jennifer L. Traylor presented the history of Xi Delta Phi Colony which originated as the Xi Delta Phi Coed Business Fraternity. The original

fraternity, established on

January 30, 1990, had its own separate purpose, motto, creed, colors, flower and mascot. In March of 1992, ten members of the fraternity contacted three national business fraternities. They were hoping to find a larger national organiza-

tion about executive officers. After the fall recruiting session, the group submitted a formal Letter of Intent to The Central Office to become a colony. Officers were elected and on December 15, 1992, and Xi Delta Phi was officially recognized as a colony of Delta Sigma Pi. Over winter break the officers held a winter retreat. They planned the upcoming recruiting functions, professional activities, and a budget. Mary Romspert, an alumni member of Delta Sigma Pi who works in the President's Office at Trenton State College, was invited to be the colony's alumni advisor. After four recruiting events the colony had 35 members. April 20, 1993, Xi Delta Phi's petition for a chapter charter was approved by the Board of Directors of Delta Sigma Pi.

Following the history of the Xi Delta Phi Colony, Grand President William R. Kinsella then presented the charge and charter to Chapter President Katherine M. Dougherty, and Executive Director Michael J. Mazur, Jr. presented Fraternal Greetings from chapters and Brothers across the country.

Trenton State College is the oldest public colleges in New Jersey. On February 9, 1855, a Senate Bill was passed for the New Jersey State Normal School. The school opened on October 1, 1855, with a total of fifteen pupils. In the 1920's the name of the institution was changed to the New Jersey State Teachers College at Trenton.

Today, Trenton State College, having started out as one building, has expanded to thirty-six buildings covering 250 wooded and landscaped areas. Eleven residence halls provide housing for 2,500 students. There are 318 full time faculty members and a student/faculty ratio of 15 to 1.

Trenton State offers programs in liberal arts and sciences, business, nursing, education, and technology. Bachelor degrees are awarded in Biological Science, Business, Communications and the Arts, Computer and Physical Science, Education, Engineering and Environmental Design, Health Professions, and Social Science. Enrollment is approximately 7,300 students.

Mu Omega Chapter, the sixth chapter to be established in New Jersey, joins the Mideastern Region and the Northern Province. Congratulations and welcome to the 35 charter members of Mu Omega Chapter.

## Today, Trenton State College, having started out as one building, has expanded to thirty six buildings covering 250 wooded and landscaped areas

and the name of the university changed from Iowa State College to its current name of Iowa State University during that same year.

The university awards Baccalaureate Degrees in Agriculture, Biological Science, Business, Communications and the Arts, Computer

and Physical Science, Education, Engineering and Environmental Design, Health Professions, and Social Science. In 1988-89, 4,041 bachelor's degrees were awarded. Currently there are approximately 25,500 students enrolled at Iowa State University.

The fraternity proudly welcomes the 24 charter members of Mu Psi Chapter as the 233rd collegiate chapter of Delta Sigma Pi.

Grand President William R. Kinsella, Northern Provincial Vice President Frederick C. Lipsey, Gulf South Regional Director Jeb L. Bertolasi, Eastern Regional Director Donna M. Smith, Mideastern Regional Director Michael J. Spadaro, Executive Director Michael J. Mazur, Jr., District Director Douglas A. Spy, District Director Kenneth S. Wilbur, and the Brothers from

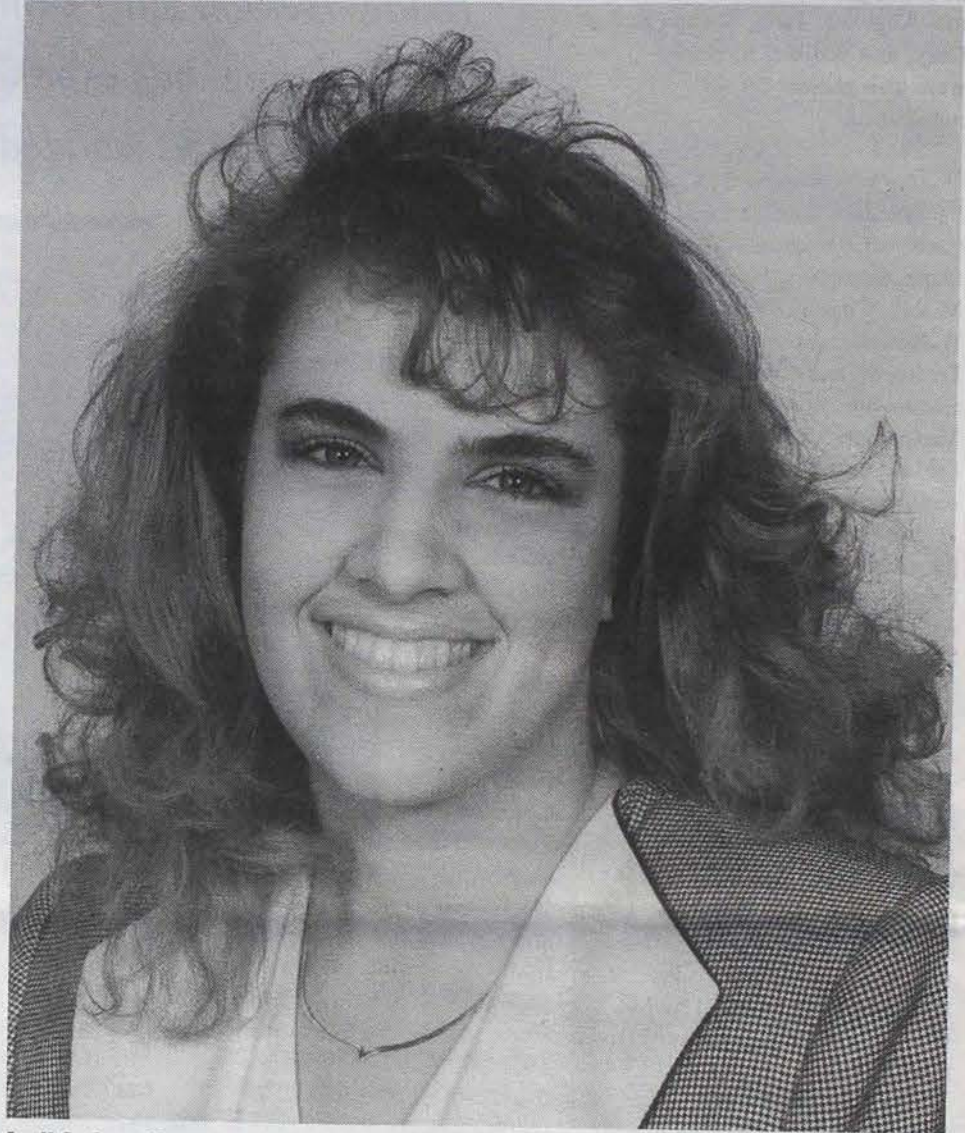

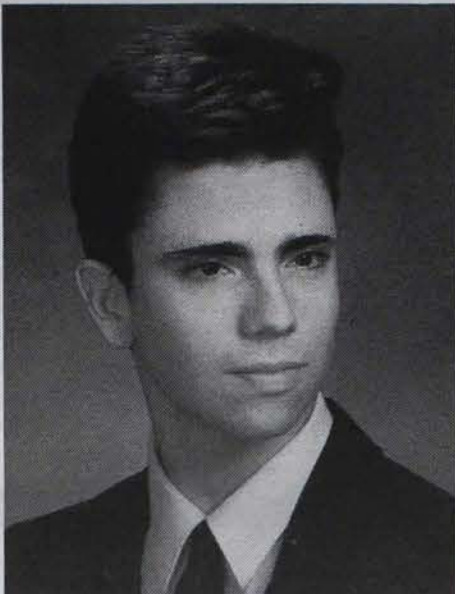
April has a variety of interest she like to pursue and is always looking for new ideas. She loves to sing and dance, go to church, play dominoes and take care of her cat, Duchess.
