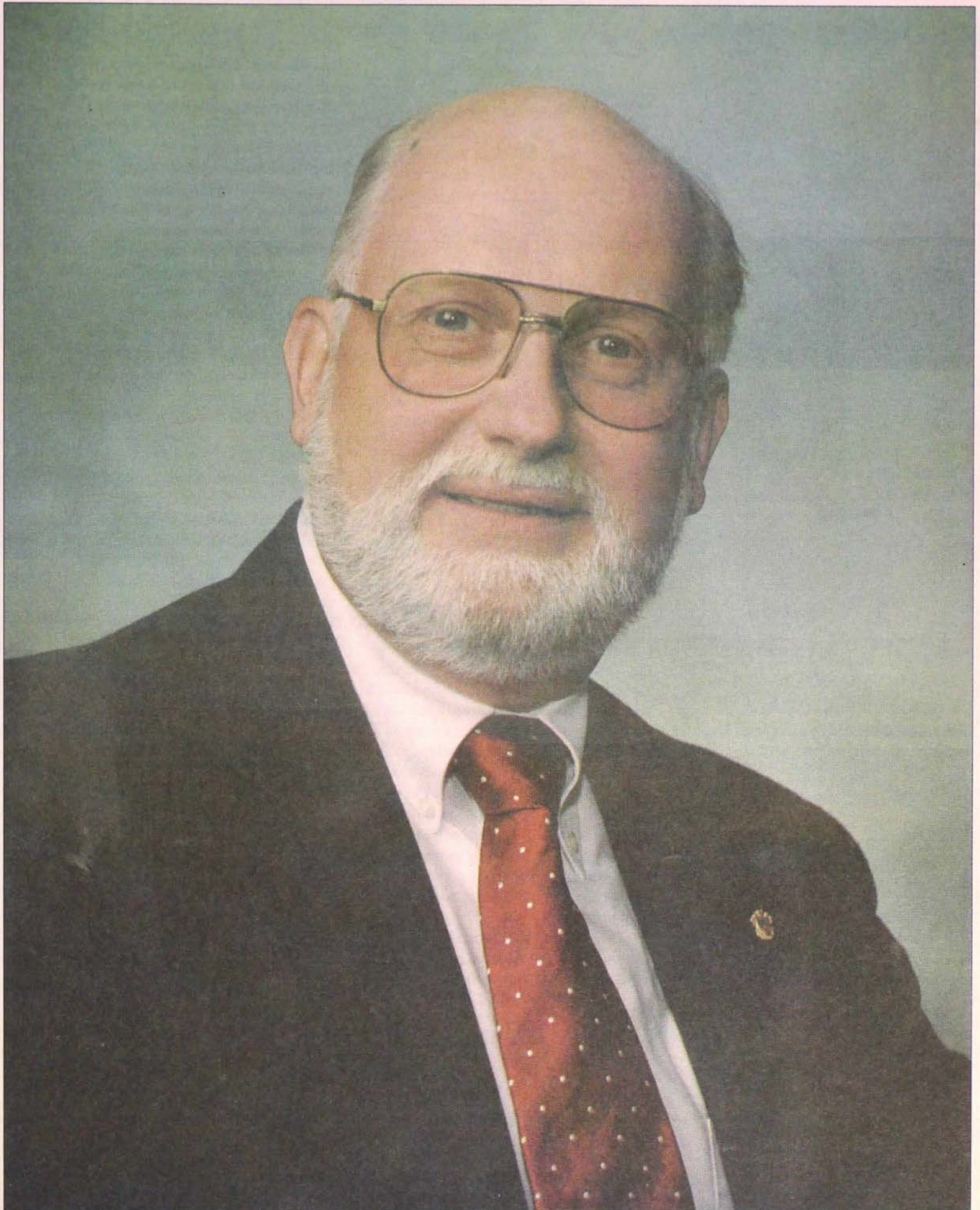

Focus ON THE FRATERNITY - GOVERNANCE

During the 1997 Grand Chapter Congress the delegates passed the following:

"Direct the new Grand President to form a new task force whose charter is to review and make recommendations regarding the management composition and structure of the Board of Directors of the International

Fraternity of Delta Sigma Pi. To be presented to the delegates of the 1999 Grand Chapter Congress."

This resolution established the need to look at the governance structure of Delta Sigma Pi. Once the delegates defined the need, the next step became defining a process to make this mission happen. Since leaving Grand Chapter Congress, I (as Grand President) spent time researching various processes. I approached this by consulting with Past Grand

Presidents, current Executive Committee members, staff members, collegiates, alumni and professional colleagues. Through these discussions, it became apparent one cannot examine the Board in a vacuum. There is need to look at the entire structure of governance. To accomplish this greater defined need, your leadership plans to utilize the process outlined below.

A commission of key people has been appointed to address the objective. The make-up of individuals in this group is critical. Each has experience in association or fraternity management. This group also has a foundation knowledge about Delta Sigma Pi. The commission includes:

Todd Mirell (California-Davis) - As commission administrator and "owner" of the issue, Todd will facilitate gathering of information from the membership. Todd wrote the Congress resolution and will provide the "owner" perspective.

Mike Tillar (Cincinnati) - Mike served on the Central Office staff from 1973-1981 as a Chapter Consultant and then Assistant Executive Director. He has significant experience with other associations, as well, having been Executive Director of the Association for Facilities Engineering for 11 years and a Director of the American Association of Engineering Societies. Along with other input, he will also assist in the development of a white paper documenting our current form of governance.

David Banner (Pacific) - David is a management professor at Wisconsin and a former chapter advisor at Pacific.

Ray Galbreth (Missouri) - Ray is Executive Director of Delta Chi Fraternity (social) and has previously been a management professor.

Keith Cobb (Southern Mississippi) - Keith, currently a business consultant and former Vice Chairman of Alamo Rental Car, provides the corporate world perspective.

Brothers Banner, Cobb, Galbreth and Tillar will collectively develop survey questions, provide insight and assist in development of the final recommended course of action.

Dawn Libbert (Central Missouri State) - Dawn will facilitate the gathering of information from the collegiate base of members. As 1998 National COY, she will represent the Executive Committee and collegiates.

The first step in the process is to complete a "white paper" documenting our current governance structure. After completion of the "white paper", the group will assess the current structure's responsiveness to the needs of the organization. To accomplish that phase, they will survey our membership via a two-part process. The first will be a formal survey available to members. This may be sent via mail, e-mail or placed on the web site. The second phase will involve direct contact with various members to "drill-down" in further detail on issues or to obtain more perspective.

If through this process the commission determines the current structure is adequate, they will complete a report stating why and their project is complete. However, if the group determines the current structure could be improved, they will proceed to develop a "product" which presents solutions to improve the structure. The goal would be to have this product available for review, not necessarily vote, but review at the 1999 Houston Grand Chapter Congress (August 18-21). They would present their product for consideration over the next two years.

The period from 1999 to 2001 would constitute the next phase of the project. During that time the commission would facilitate a period of evaluation, review and refinement. The process for this phase would include soliciting feedback from focus groups such as the Board of Directors, Executive Committee, Golden Council, Past Grand Presidents, Central Office staff members, outside professional organizations, legal council and our accounting firm. These focus groups will then provide input to refine the product for review at the 2000 Regional Conferences. After the Regional Conferences, the product would be prepared for delegate action at the 2001 Grand Chapter Congress.

The desired outcome of this long scenario is simple. We need to examine our governing process to be certain it meets the needs of our members and the organization well into the future. Considerable input has been received in recent years that our government could likely be streamlined and simplified to be more responsive to changing times. The commission, with the input of Brothers like you, will recommend the course of action that best serves Delta Sigma Pi for years to come.

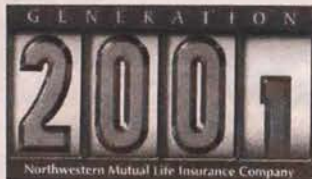

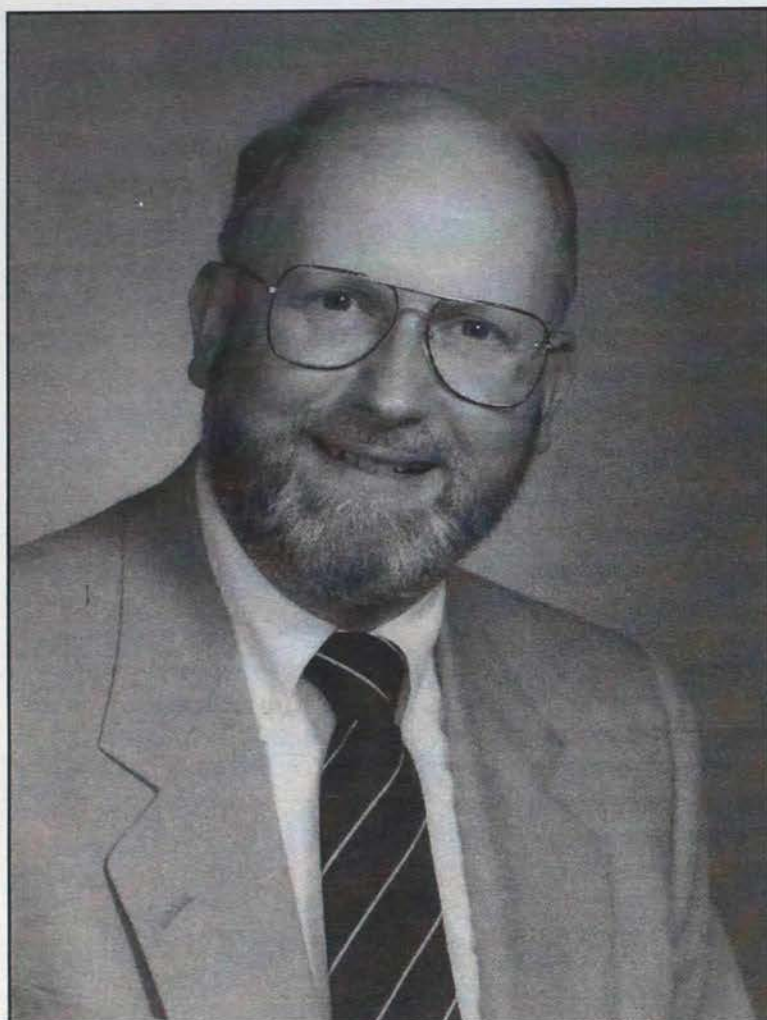

1997 Lifetime Achievement Award to Richard J. Parnitzke

Delta Sigma Pi's Highest Honor

The Lifetime Achievement Award is the highest honor any Fraternity member can receive and is issued annually to the one Brother who has demonstrated exemplary support, service, and leadership to the Fraternity.

It's a sincere pleasure to take a few moments to share some thoughts and memories of Delta Sigma Pi Lifetime Achievement Award recipient Richard J. (Dick) Parnitzke. In my fraternal life, I have experienced the good fortune to have served Delta Sigma Pi as a volunteer and as Executive Director and, throughout those years, I was equally fortunate to have met and worked with thousands of Brothers. Dick Parnitzke is one of those Brothers who has become a good friend - a friend for life.

Richard J. Parnitzke was initiated into the Alpha Kappa Chapter at the University of New York at Buffalo on May 1, 1971. As a non-traditional student, he pursued his degree on a part time basis while working at General Motors as a Cost Analyst. During his collegiate years in Alpha Kappa Chapter, he served as Senior Vice President, Public Relations Director, and Advisor. After his graduation from college, Brother Parnitzke was appointed as a District Director and served in that role from 1973 until 1976. In addition to his duties as a District Director, he served Delta Sigma Pi on several national Fraternity committees and on the Board of Directors of the Buffalo Alumni Chapter.

In 1976, the position of Eastern Regional Director became open and Dick was selected to fill the vacant term until the Grand Chapter Congress scheduled for August of 1977. Elected to a full term

in 1977, he served with distinction in the Eastern Region until 1982 when he was elected to serve as the Director of Alumni Activities for the Fraternity.

During his tenure as Director of Alumni Activities, Brother Parnitzke helped devise and develop training guides for alumni chapters and for district directors. His active involvement was recognized in 1983 by the Delegates to the Grand Chapter Congress who elected him as Grand President. Little could he predict that at that Congress, his daughter Kathie, then a student and Deltasig at Miami University, was to meet her husband, Brother Mark Slusher of Nu

Chapter at Ohio State University.

The 1983 Grand Chapter Congress was also the beginning of the Fraternity's relationship with Junior Achievement (JA). Karl Flemke, then Chairman of Junior Achievement, was initiated as the National Honorary Member and face-to-face discussions were held about an alliance between JA and Delta Sigma Pi that was originated during the administration of Grand President Michael Mallonee. Shortly after his election, Grand President Parnitzke and I traveled to JA headquarters to meet with Karl Flemke and other chief JA officials to

finalize the alliance between JA and Delta Sigma Pi that continues to this day with recent revitalization efforts.

Brother Parnitzke continued to serve the Fraternity on the Board of Directors and Executive Committee after his term as Grand President ended in 1985. His service on the Board of Directors lasted thirteen years and his service on the Executive Committee for ten years. He continues to

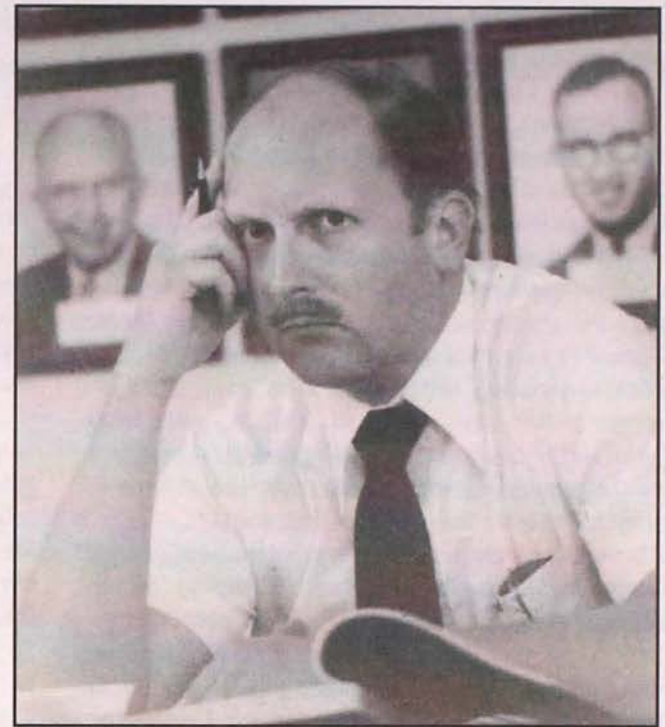
offer his input and services to the Fraternity on an ongoing basis, on all issues from discipline to expansion.

Some of the more poignant memories about Brother Parnitzke have been formed at the various Grand Chapter Congresses he has attended. For many years, the four Parnitzkes attended every Congress, starting in 1973 in Portsmouth, New Hampshire. I recall the 1973 Congress in

this way: "It was a wonderful experience - one that clearly told me, 'this organization that you joined a few months ago is one to which you should give something back because it has already given so much to you'. At that Congress, Dick Parnitzke, the man with the unusual name, was the winner of the diamond badge raffle and his daughter Kathie won a prize that evening as well. While my cynical '70's college student reaction was 'this raffle must be rigged'; I observed a man with an obviously loving family."

During his years as Grand President, Richard and Jackie Parnitzke visited Oxford often to see their daughter Kathie. Kathie and Lisa Parnitzke were regular participants at Grand Chapter Congresses throughout their childhood so it is only fitting that Kathie would meet her husband at a Congress. The weekend of Kathie and Mark's wedding was a distinct Deltasig event with Brothers from throughout the country in attendance. From the joy of that weekend, we were saddened by the tragic death of Jackie Parnitzke what seemed just months later. With an abundance of inner strength, Dick, Kathie, Mark, and Lisa pulled together and moved forward in their lives. Today, Dick is happily remarried to Diane Parnitzke and they share their five children.

A banquet has been planned for Saturday, August 15, at the Adams Mark Hotel in downtown Buffalo to honor this extraordinary man and exemplary Deltasig. I hope you will join me in honoring Richard J. Parnitzke, Lifetime Achievement Award recipient. ▲

Move Over, World

New study provides sweeping snapshot of America's next generation

Make Way for Generation 2001

Technically, they will constitute the first college graduating class of the new millennium. They are the Class of 2001 - Chelsea Clinton's class. They also represent the foremost wave of masses to follow - the youth of America who will be the first to transition into adulthood during the 21st century. Having just completed their freshman year, they are distinguishable as among the front line of our nation's newest generation - a group that has spent its formative years observing the examples, for better or worse, set by three generations before them: GenXers, Baby Boomers and Matures.

Meet Generation 2001 - or at least a fully, nationally representative cross section of 2,001 freshmen from this generation - all from 101 colleges and universities around the country who participated in a Louis Harris & Associates survey released earlier this year.

The unprecedented survey was commissioned by Northwestern Mutual Life Insurance Company, which for 30 years has sponsored one of America's best college internship programs, as ranked by *The Princeton Review*.

The Northwestern Mutual Life study, called "Generation 2001; A Survey of the First College Graduating Class of the New Millennium," provides the first bona fide glimpse into what's going on in the hearts and minds of this newly-named generation.

"The new century and the new millennium provide an ideal occasion to study an age group that for years has had tremendous business significance for our company," said Deanna L. Tillisch, director of the Generation 2001 study for Northwestern Mutual. "Two-thirds of our top 100 agents started with the company at the age of 25 or younger. In fact, 25 percent of Northwestern Mutual's almost 7,500 agents began their careers with us during their college days. Clearly, college students are important to us. We want to know what they're all about."

So, what do the early returns tell us about this new generation?

"Top line results of the survey show a certain 'sense and sensibility' about this group - a well balanced mixture of mind and heart," Tillisch said. "On the one hand,

the sensibilities of Generation 2001 students appear to be alive with idealism, optimism and a vision of a better world. On the other hand, they also appear to be well-grounded. This generation is not so blindly idealistic or optimistic as to deny the realities of life, or that there are challenges and issues to face."

Tillisch said the students who participated in this very fine Generation 2001 survey are "extremely motivated toward realizing their hopes and aspirations for a bright future for themselves and for America. Already, they have established specific goals for themselves. They are truly confident they'll be able to afford the kinds of life-styles in which they were raised."

Further, Tillisch said, "Generation 2001 students tell us they're satisfied with their looks. They say they've got religion. They have big plans for marriage and family. They intend to vote. They believe that helping others is more important than helping themselves.

"They believe it's quite possible in their lifetime that there will be a U.S. president who is a woman or person of color. They have a deep respect and admiration for their parents. They'd be willing to fight for their country. Half of them are so confident with themselves they'd even live in outer space if the opportunity were given to them," she said.

Tillisch said, "the students who participated in the Generation 2001 survey realize that it's probably going to take two incomes and long hours on the job to realize their dreams of marriage, family and lifestyle. They also realize marriages don't always work. And the majority agree that divorce is an acceptable solution if two people are unhappy in a marriage."

Their Career Goals And Aspirations

Nearly half (47%) of the students participating in



around the country about their hopes and aspirations. The study, called "Generation 2001: A Study of the First College Graduating Class of the New Millennium," was conducted by Lou Harris & Associates.

the Generation 2001 survey plan to immediately enter the workforce upon graduating. While most (62%) would not consider doing what either of their parents do, a significant 37 percent would consider following in mom's or dad's footsteps.

Popular careers among Generation 2001 students include education/teaching, medicine, **business**, computer-related fields, law and psychology.

Along with having idealistic and committed co-workers and doing work that gives them opportunity to help others.

Starting salary hopes for this group average \$38,000, although fully 42 percent do not expect to be earning more than \$30,000 when they begin their careers.

On another note, perhaps there are jobs in outer space for Generation 2001 students. Half (50%) report an interest in living there if in the future it becomes possible to live aboard a space station or on another planet.

"Much is said about the materialistic tendencies of younger generations," Tillisch said. "However, this survey does not paint a picture of students who are greedy, over-aggressive and willing to do whatever is necessary to get ahead. Rather, the research conveys an impression of a generation that some might say has idealistic and naive expectations of future career plans. Even though Generation 2001 students have not had to experience much of the real world on their own, they recognize that they need to work hard to achieve good things and work with like-minded creative and idealistic people. In return, they will be rewarded with a lifestyle that they grew up in. And, yet, this will still require the need for a two-income household."

David Krane, executive vice president of Louis Harris & Associates, summarized the findings of the Generation 2001 survey by saying "All new generations build on the experiences of the previous generation. Look at this group and you'll see some common threads from the past as well as different qualities.

"What makes this generation special is the mixture of the idealism and optimism of youth with a surprisingly realistic view of the world," Krane said.

"Generation 2001 students are not as radical as we saw in the 1960s, nor as materialistic as people in the 1980s," he said. "If Gen2001 is going to change society, it will do so by working within the system. Where some might say these students are naive, others would say that what is most surprising is that this group seems particularly enlightened - and even mature - when it comes to certain aspects of their lives."

Brother Libbert was named the Midwestern Regional Collegian of the Year and received a scholarship and jeweled Fraternity badge made possible by the Clyde Kitchens/Thoben Elrod Foundation. She is also eligible for a graduate scholarship made possible by Mr. and Mrs. Sidney A. Sparks through the Delta Sigma Pi Leadership Foundation which she will be utilizing in the fall at Central Missouri State. In August, Dawn will begin a two-year term on the Fraternity's Executive Committee and Board of Directors.

Dawn has consistently exhibited a high level of service and commitment both to Delta Sigma Pi and her university throughout her undergraduate years. Her Fraternity offices include terms as senior vice president in 1996 and president in 1998. Her honors include being named "Most Motivated Officer," "Outstanding Officer" and "Outstanding Executive Member." These winners were selected from the nominees submitted by chapters in the Region. Each Brother selected receives a scholarship in the amount of \$250 made possible by an endowment from the Kitchens/Elrod Foundation.

The Clyde Kitchens Foundation was established by Brother Thoben Elrod in 1975, "to perpetuate the memory of Clyde Kitchens and to enable future generations to carry forward his interest in Delta Sigma Pi." The name was later changed to reflect the leadership provided by Brother Elrod. The Foundation's funds were the result of proceeds from an endeavor by Kappa Chapter Brothers and other business students at Georgia State in the 1930s. These students formed an investment club which purchased stock and real estate that led to the formation of a lodge which was used by the Chapter for many years. The sale of this property in the 1970s has provided funding for a variety of other invaluable programs.

Brother Clyde Kitchens was initiated into Kappa Chapter at Georgia State in 1929 and served as Chapter Advisor. He passed away in 1969.

Brother Thoben Elrod was a 1936 initiate of Pi Chapter at Georgia where he served as Chancellor. He also served as a national officer, was a member of the Golden Council and a voting member of the Educational Foundation. Brother Elrod passed away on March 30, 1997, at the age of 82.

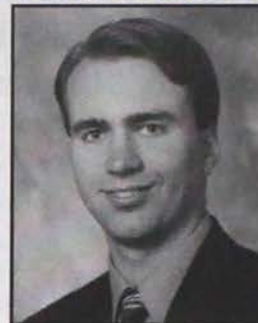

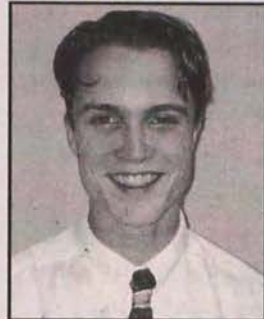

of the Year program, though rumored to be torturous, is actually very painless and straightforward. Here's how the application and selection process will take place for the 1999 Collegian of the Year:

* When the 1998-99 school year begins in the fall, your chapter will begin receiving publicity about the Collegian of the Year program.

* At a chapter business meeting, the chapter Collegian of the Year will be selected. This Brother then becomes eligible for the Regional Collegian of the Year competition.

* Each chapter Collegian of the Year will complete the application packet (which is considerably more streamlined than it was three years ago) and mail it to his/her Regional Director by December 15, 1998.

* The Regional Director will appoint an alumni committee to review all applications received. The committee will rank the applications, then take a final vote to select the regional Collegian of the Year.

* The regional winner will be notified in the January / February 1999 time frame. This individual will receive a pearl-and-ruby Delta Sigma Pi badge, a stipend from the Leadership Foundation, and will become automatically eligible for the national Collegian of the Year competition.

* The national selection will take place at the February 1999 Executive Committee meeting. The winner of the 1999 Collegian of the Year award will be notified by phone in the days following the selection.

Brothers that are interested in applying for the Collegian of the Year award should contact their chapter president or secretary for more information, or call the Central Office directly. I strongly encourage each and every chapter to nominate a Collegian of the Year candidate and support the candidate in completing the required application. I know that there are a lot of qualified Brothers out there who are willing and able to serve in this position!

In closing, I'd like to impart a few "words of wisdom" from my experiences in this, the world's foremost professional business fraternity. I've written much about opportunity in this article. I sincerely believe that the primary product of this organization, however intangible, is opportunity. I can think of no other organization that

I've participated in, heard of, or read about that offers so much to its membership for so little. But it is the responsibility of each Brother in Delta Sigma Pi to take advantage of the opportunities that are provided. There are so many activities to get involved in, so many people to meet, and so many causes to help that every Brother in our Fraternity should have an opportunity of their own. What he or she does with that opportunity is up to the individual. I was fortunate enough to make the most of the opportunity that I was presented. I urge you, Brothers...please make the most of yours. You will profit immensely, as will Delta Sigma Pi.
