
Dear Sir:

## PETITION

We, the undersigned officers of Tau Delta Rho Fraternity, a local Commerce Fraternity, vested with power to act by unanimous vote at a regular meeting, are united in our desire to establish a chapter of The International Fraternity of Delta Sigma Pi at DePaul University embracing the membership of Tau Delta Rho Fraternity.

The College of Commerce has at present an enrollment of over nine hundred of which approximately seven hundred and fifty are men. Tau Delta Rho Fraternity has used the utmost care and diligence in selecting its membership, taking into consideration the following qualifications:-

All candidates must have at least fifteen high school credits and completed one semester work in the College of Commerce. In the event of a deficiency in high school credits, work in the College of Commerce is accepted as a substitute at the rate of one semester hour for each deficient high school credit.

His grades must be above the average.

Only Gentiles and those of the Caucasian Race are considered.

Each man is personally investigated and found to be of excellent moral character with ambitions that will make him an honor to our organization.

We hope to be able by our admittance into a National Organization to further its and our interests in academic, professional and social life. It is our belief that this will create a closer bond of fellowship among the students



of the various institutions.

In order to enjoy the rights and benefits of a national organization such as Delta Sigma Pi we will uphold its constitution, ideals and traditions and obey its by-laws.

## HISTORY OF DE PAUL UNIVERSITY

DE PAUL UNIVERSITY owes its origin to the good will and encouragement of a number of Chicago's worthiest citizens - - men of note in the legal or medical professions or prominent in the affairs of business - - in compliance with whose earnest and repeated requests and incitements the old College was elevated to the rank of a University by virtue of a charter dated December 24th, 1907 and issued under the seal of the State of Illinois. The charter of organization gives the right "to provide, impart, and furnish opportunities for all departments of higher education .....which may comprise and embrace separate departments for literature, law, medicine, music, technology, the various branches of science, both abstract and applied, the cultivation of the fine arts, and all other branches of professional and technical education which may properly be included within the purposes and objects of the University."

To fulfill as many of these purposes as the institution is at present capable of fulfilling, and to secure therein the best results in administration and instruction, the following departments have been organized.

THE COLLEGE OF LIBERAL ARTS AND SCIENCES, comprising the following departments: Philosophy, English, Ancient Classics (Latin and Greek), Modern Languages, Political Science, History, Sociology, Cosmography, Biology, Physics, Chemistry and Mathematics.

THE COLLEGE OF LAW, offering courses leading to the degrees of Bachelor of Laws (LL.B.) Doctor of Law (J.D.) Master of Laws (LL.M.) and Doctor of Civil Law (D.C.L.).

THE COLLEGE OF ENGINEERING, offering courses in

Civil Engineering	Electrical Engineering
Mechanical Engineering	Chemical Engineering

THE COLLEGE OF COMMERCE, offering courses leading to the degrees of Bachelor of Science and Master of Science.

THE SCHOOL OF MUSIC, offering instruction in Theoretical and practical music.

## BUILDINGS AND CAMPUS

The University is located on the North Side of Chicago, about ten minutes walk from Lincoln Park, occupying the entire block bounded by Webster, Belden and Sheffield Avenues and Osgood Street. Here are located the College Building, the Administration Building, the University Gymnasium and the Athletic Field.

Adjacent to the campus are situated the College Theatre and the Lyceum. The College Theatre is one of the most beautiful auditoriums in the city and has a seating capacity of 1,500. The Lyceum is a two story building containing thirty rooms and all the students can enjoy the advantages afforded by its parlors, reception and reading rooms.

In addition to the University building on the North Side, a seven story building, situated in the heart of the city, on Randolph Street near Michigan Boulevard, is occupied by the College of Commerce.



## HISTORY OF THE COLLEGE OF COMMERCE

The College of Commerce of De Paul University was organized in 1912 as a regular department of the University. In 1914, the school was transferred downtown, taking space in the Powers Building. The following year, larger quarters were needed, which were secured in the Tower Building. With the rapid growth of the College of Commerce after the War, it was found necessary to secure the ample space afforded by a seven story building on Randolph Street near Michigan Boulevard.

In this location, the school has an admirable location for a college of commerce, being right in the center of the business district. The building is adjacent to the John Crerar Library and directly opposite the Chicago Public Library.

On the other hand, transportation facilities are perhaps the best in the city, within one hundred feet of the building, one has access to the suburban railroad service, the suburban electric service, the elevated trains and the surface lines.

The College of Commerce, as organized, is in a position to aid in equipping its students for success in the larger, more remunerative and intricate affairs of business, and to this end it offers an advanced course of a strictly university and professional character.



New De Paul University Building.

This building is being erected at Lake Street and Garland Court. It will be sixteen stories high and will house the Colleges of Law and Commerce, as well as the Evening Commerce School and Loop High School. The top six floors will be used for the school. The first ten will rent as office space. This building is to be ready May 1-1928.



PROFESSIONAL FRATERNITIES AND LOCAL  
ORGANIZATIONS AT DE PAUL

The Phi Alpha Delta and the Delta Theta Phi, both national law fraternities have chapters at De Paul, established in 1897 and 1904 respectively, as has Kappa Beta Pi, a national legal sorority, established in 1926. Tau Delta Rho, professional commerce, one of the leading local fraternities, was established in 1921. Alpha Chi and Sigma Delta Kappa, national social fraternities are also established at De Paul.

A number of clubs and organizations formed by the students are in a flourishing condition and continue throughout the year. Among the more prominent are - De Paul Literary and Debating Society, The Wig and Mask, Glee Club, Commerce Club and the standard various class organizations.

## HISTORY OF TAU DELTA RHO FRATERNITY

Tau Delta Rho Fraternity was organized by students of De Paul University College of Commerce in May, 1921 to fill a need for a commerce organization that would promote and further the interests of the student body of the College of Commerce and compare with other professional fraternities established in other universities, aiding in the attainment of better scholarship and social life among its members and to co-operate wherever possible with the faculty in any manner to promote the general welfare of the University. Accordingly, Albin K. Hornoff, Paul J. Bruch, Edward C. Fortman, Raymond J. Lorenz and Frank S. Green, all regular enrolled students of the College of Commerce of De Paul University founded a Fraternity under the name of Alpha Chapter, Tau Delta Fraternity, De Paul University and on May 14th, 1921, were granted a charter by the State of Illinois.

- "1. To promote higher scholarship and fraternal interest among the students of De Paul University and other Universities in the State of Illinois.
2. To provide a constitution and by-laws for the government of the affairs of said organization with power to amend, alter and revise the same in the manner to be provided therein.
3. To provide a Ritual and Ceremonies needed in a secret fraternal order.
4. To superintend the organization of fraternities of like name and object in other Universities of the State of Illinois and to provide for the affiliations of such organizations with this, the first fraternity organized under this name."

From this humble beginning, Tau Delta Fraternity has enjoyed yearly



growth assuming many cherished traditions.

In 1924, the name was changed to Tau Delta Rho to agree with a new Ritual and because of the discovery of a High School Fraternity operating under a similar name.

The membership at present consists of twenty students, fifty alumni and five honorary members, all of which are more or less in close touch with one another.

Tau Delta Rho is very prominent in student life. The class officers and Commerce Club Officers are invariably members of Tau Delta Rho. In the past four years scholarships or medals have been won twice by members. Tau Delta Rho's social affairs are among the outstanding functions of the student calendar and their slap stick initiations and pledge probation stunts have long served as models for other Fraternities and Sororities at the School.
