HISTORY

HISTORY OF THE CITY OF ALLENDALE AND GRAND RAPIDS

Allendale, whose name was said to be taken from the old Scottish song "The Rose of Allendale", lies on the Grand River halfway between the city of Grand Rapids and Lake Michigan. Indians were the first to settle here, but trouble between the Muskatay and Ottawa Indians caused many battles, and most were killed. Soon the settlers came and started to cut down the trees for lumber and for farming. The first steps towards organization occurred in 1848 and Allendale was chartered as a township in 1849. Being situated on the Grand River helped the town prosper, for it was the most convenient, rapid and economical way to move cargo to Lake Michigan in the early days.

Today, it is still a small rural town in the shadow of Grand Rapids, Michigan's second largest city.

Grand Rapids was founded in 1850 and has been a predominant city since its founding. Known as the Furniture City (because of its many quality furniture manufacturers), it has a population of approximately 180,000.

Because of the fine cultural atmosphere that the city exhibits, Grand Rapids was voted an All-American city in 1981. The annual downtown Summerfest, a celebration of the arts, brings about half a million people to the city for a wonderful June weekend of song, dance, artwork and, of course, food from many nations. Another attraction that makes Grand Rapids special is the Gerald Ford Museum, which is filled with memorabilia of former United States President Gerald Ford, a former Grand Rapidian.

With the advantages of a small, quiet town like Allendale and the atmosphere of a growing metropolis, such as Grand Rapids, right in our backyard, students at Grand Valley State College can have the best of both worlds.

GRAND VALLEY STATE COLLEGE
PAST, PRESENT AND FUTURE...

Grand Valley State College was established in 1960 by the State of Michigan. The site for the campus was chosen and the funds (totaling \$358,483) to buy the property, were all donated by private sources. In 1961, plans for the general development of the campus were begun with the appointment of Johnson, Johnson and Roy, Inc. as campus planners.

The first two buildings, Lake Michigan Hall and Lake Superior Hall, were designed by Mathe, Kessler & Associates, Inc., of Grosse Pointe, and were substantially completed by September of 1963 when the College opened its doors for the first days of classes. That first semester saw only 226 students and 15 faculty members. Twenty years later, the total had grown to 6700 students, a regular faculty of 212 (70% of which have a PhD or similar terminal degree) and a support staff of 334. This growth was attributed to Grand Valley's unusual union of colleges. Prior to the fall of 1983, Grand Valley consisted of 6 separate colleges, all sharing the same facilities but independent of one another in terms of educational philosophy, study approaches, course requirements, grading systems, faculty and support staff. There were four undergraduate colleges (College of Arts and Sciences, Thomas Jefferson College, William James College and College IV) and two graduate colleges (F.E. Seidman Graduate College and Graduate School of Education). In the fall of 1983, all six colleges combined under one administration with common goals and requirements.

Grand Valley State College prides itself on its quality of instruction and exceptional learning environment. G.V.S.C. is a teaching institution whose instructional offerings include over one hundred academic and career preparation programs leading to fully accredited college degrees in 78 major areas. The quality of this education is enhanced by the environmental factors of small class sizes, individual student advising and career counseling.

To aid the faculty in their professional advancement the Center for Research and Development is very active. Students also have the opportunity to take part in the projects directed by the faculty. These projects consist of laboratory or field-based work, library research and creative/fine/performing arts projects. Student involvement in these projects helps to generate new knowledge and is an invaluable learning experience to the student.

DESCRIBE YOUR INSTITUTIONAL ENVIRONMENT AND THE POPULATION FROM WHICH YOU DRAW THE STUDENTS ENTERING YOUR PROGRAMS.

Grand Valley State College is one of fifteen state-supported institutions of higher education in Michigan, and the only one located in the greater Grand Rapids area, the second largest population center in the state. Situated in Allendale, approximately 12 miles west of downtown Grand Rapids, Grand Valley provides educational services primarily to the residents in the counties of Kent, Ottawa, and Muskegon. These three counties have a population of approximately 750,000.

The Grand Rapids metropolitan area has the most diversified economic base of all metropolitan areas in the state with one of the lowest unemployment rates. Most of the businesses are small (fewer than 500 employees) and the key durable goods industries are not linked to automobile production. The service industry in West Michigan has grown rapidly in the last ten years. Today, for example, five of the big eight accounting firms have offices in Grand Rapids to complement the many other fine accounting organizations. Ten years ago, only three of the big eight had offices in this area.

Although Grand Valley attracts students from most counties in the state, roughly two-thirds come from the tri-counties. Over ten percent come from the Detroit area and only one percent from outside the state.

Institutional enrollment, for the fall of 1983, was 6,710 students, made up of 5,624 undergraduate and 1,086 graduate students. The student body was comprised of 45.3 percent first-time-in-any-college students and 54.7 percent transfer students. Over 1,000 of the transfer students came from two community colleges, Grand Rapids Junior College and Muskegon Community College. Almost sixty percent of Grand Valley's students were full-time, although almost all of the graduate students were part-time. The average age of the undergraduate students was 24.5 years, and of the graduate students, 32.6 years. Approximately one-half of the undergraduate students and ninety-eight percent of the graduate students are employed and attending school on a part-time basis.

The campus is on an 876 acre bluff, criss-crossed by deep, wooded ravines. The eastern boundary of the campus is the Grand River, and the western boundary of the campus is rolling meadows. The campus is split into northern and southern halves by a 70 foot deep ravine spanned by a 230 foot pedestrian bridge called the "Little Mac" bridge.



-James H. Zumberge Library was named after our first President. It contains +333,000 volumes, 1800 periodical subscriptions and 13600 reels of microfilm.



-Kirkhof Center houses Student Services, the bookstore, snack bar, meeting rooms, T.V. lounge area and a games room.



-Alexander Calder Fine Arts Center was named after the artist whose stabile the Grand Vitesse is a Grand Rapids landmark. The Center houses practice rooms and teaching studios for the performing arts, and the 490-seat Louis Armstrong Theatre.



The South Side:

- Lake Michigan Hall houses the School of Health Sciences, Hospitality and Tourism Management Program and the School of Nursing.
- Lake Superior Hall houses the School of Communications, English and Philosophy Departments, and the Office of the Dean of the Arts and Humanities Division.
- Lake Huron Hall houses the Seidman School of Business and the Continuing Education Office.
- Seidman House was named after the Thomas Erler Seidman Foundation which donated the funds for its construction. Seidman House houses Admissions, Financial Aids and the Registrar's Offices.
- Au Sable Hall houses the Department of Education and Foreign Language, History Department and the Planning and Resource Management Division.
- Cedar Studios houses the Print-making, Art Education, Drawing and Painting facilities with a nearby ceramics laboratory.

The North Side:

- Mackinac Hall houses the Division of Social Sciences Office, Math and Computer Sciences Offices and a Microcomputer Laboratory.
- Manitou Hall houses lecture halls, the T.V. Station (WGVC/WGVK), Computer Center and Media Services.
- Loutit Hall of Science was financed in part by funds from the Loutit Foundation of Grand Haven. It houses lab facilities for study, research and experimentation in the natural sciences.
- The Commons accomodates the resident's dining room, the Housing Office, Academic Resource Center, Career Planning and Placement Center, a snack bar and the Campus Ministry.
- Field House and adjacent Arend D. Lubbers Stadium (named after our current President), houses indoor/outdoor tracks, tennis, baseball, basketball, olympic size swimming pool, weight training room, human performance lab, Physical Therapy Offices and the Student Health Center.
- The Student Residence Halls are each named after a founding member of the College's governing body. The buildings house a total of 900 students and curve in an "S" shape along the rim of a ravine.
- On-campus apartments are townhouse style complexes built along the rim of another ravine. The apartments house approximately 350 upperclass students.

HISTORY OF SEIDMAN SCHOOL OF BUSINESS

Seidman School of Business was named in honor of the late, great Frank Edward Seidman, a partner in the national accounting firm of Seidman & Seidman, as well as a distinguished member of the Grand Rapids business community.

Seidman School of Business was originally known as Seidman Graduate College (SGC). Until 1979 it offered two degrees: a master of business administration and a master of public administration. In the fall of 1979, the master in the science of taxation program was started.

Prior to the fall of 1983, SGC combined with the undergraduate program, becoming known as Seidman School of Business, and the offices were moved from Seidman House to Lake Huron Hall. The school then offered a bachelor degree of business administration with an emphasis in any one of the following: accounting, finance, management, and marketing, with subemphases available in facilities management, personnel and labor relations management and technologies management.

GAMMA PHI SIGMA

In the fall of 1982, the idea of beginning a chapter of Delta Sigma Pi on Grand Valley State College's campus was first introduced by Scott Kanig. Due to poor timing, efforts were postponed.

Later, in the fall of 1984, the notion resurfaced; and this time, it took hold. On November 12, 1984, there was an open meeting on campus to determine the number of people who were interested in an all-business fraternity. There were twenty-six students in attendance at that initial meeting.

On December 12, 1984, and on January 10, 1985, there were informal meetings held between the current officers and Professor Jim Wolter, Faculty Advisor to Gamma Phi Sigma, Mike Melinn, alumni of Delta Sigma Pi and Director of Undergraduate Relations, and Dave Templeton, alumni of Delta Sigma Pi and Secretary of the West Michigan Chapter. At these meetings, the goals of Gamma Phi Sigma were restated. There was also discussion on future recruiting functions and petitioning the National Fraternity.

On January 13, another meeting was held and fundraising and recruiting ideas were generated. Weekly meetings were scheduled.

On January 24, a formal letter was sent to the Dean of the Seidman School of Business, Marvin DeVries, to ask for his support and approval in organizing a chapter of Delta Sigma Pi on campus. Also, that evening, Scott Kanig, CPA, and alumni from the West Michigan Chapter spoke to the members of Gamma Phi Sigma about changes in tax, law, and current tax-related topics.

On January 30, there was a formal recruiting function.

During the months of February and March, the colony grew in membership and in learning how to become more structured.

At the April 11 meeting, promotional ideas were discussed as well as the scheduling of a couple of informal summer meetings.

On July 8, an intent to petition was sent to the National Fraternity.

During the summer, on August 18 through 22, the President and Chancellor attended the Grand Chapter Congress in Dallas, Texas.

On September 13, 1985, there was a recruiting event, and additional recruiting function on October 1.

The increase in membership enabled Gamma Phi Sigma to coordinate various guest speakers, tours, and fundraisers. Weekly meetings were once again established.

On October 11, Mike Walsh, Assistant Executive Director and Managing Editor of Deltasig, met with Gamma Phi Sigma. He offered encouragement and suggestions to our colony pertaining to our goal of becoming installed as brothers.

On October 15, our colony toured Steelcase, Inc.

On November 2, we raffled off our six-foot, Paddington

Bear. This was our first fundraiser.

On November 14, Gamma Phi Sigma sponsored Mr. Frank Merlotti, President and Chief Operating Officer of Steelcase, Inc. in a speaking engagement at Grand Valley State College.

Our second fundraiser was held on November 23. It was our "Dare-to-be-Different" dance.

During the months of November and December, members of Gamma Phi Sigma visited area high schools to expose the students to the various opportunities within the business curriculum.

On December 4, we had a recruiting function.

With the new year, the brotherhood among the members of Gamma Phi Sigma grew. Our goal of becoming true brothers was in sight.

Our first meeting of the semester was on January 15, 1986, and on January 17, C. Dean Ferguson, Director of Chapter Services, came to Grand Valley. On that day and the following day, he spoke to us about the pledge process, and we set April 19, 1986 as the date of official installation.

On January 28, Al Walzak, from Grand Valley State's Academic Resource Center, addressed the issue of Time Management with the members.

On February 4, we held a recruiting function.

During February, our fundraisers included submarine sandwich sales and selling helium-filled balloons for Valentines Day.

On February 21, Rochester Products, a division of General Motors was toured.

On February 25, thirty-one members were officially pledged in a ceremony conducted by Mike Melinn, Dave Templeton, and visiting brothers from Ferris State College's Delta Rho.

On March 13, George Chumakos, Director of the Manufacturing Division at Chrysler Corporation, spoke on Grand Valley's campus. This well-attended event was sponsored by our colony.

On March 14, we toured the Amway Headquarters.

On March 21, we toured Seidman and Seidman, one of the Big-Eight accounting firms.

Our fundraiser for March was a microwave raffle.

Our fundraisers for April included; a bake sale, a garage sale, and a food-eating contest. Ground work is being laid for a Florida Trip raffle next year.

A goal realized, on April 19, 1986, we were officially installed by the representatives from the Central Office.
