**9.** Who makes up the "Organizational Members" as defined in the Risk Management Policy? Organizational members are defined as collegiate, alumni and faculty members; pledges; colony members; and employees.

#### 10. What are the categories of the Risk Management Policy?

- Alcohol, Drugs, and Fraternity Events
- Hazing
- Discrimination
- Assault & Battery
- Sexual Misconduct
- Weapons, Firearms, Explosives, Incendiary Devices
- Chapter Houses and Meeting Facilities
- Retaliation

#### 11. In what situations are alcoholic beverages allowed at Delta Sigma Pi events?

Alcohol is prohibited at pledge meetings, the Pledging Ceremony, chapter business and executive committee meetings and the Initiation Ceremony. Alcoholic beverages must either be: (1) provided and sold on a per-drink basis by a licensed and insured third-party vendor (e.g., restaurant, bar, caterer, etc.); or (2) brought by individual members and guests through a bring your own beverage ("BYOB") system.

#### 12. Who do you first contact with a risk management emergency?

If there is an emergency related to risk management that requires immediate attention, first call 911 or campus security to ensure the individual(s) receive appropriate emergency care. Cooperate with emergency personnel and law enforcement officials.

13. If you have an incident with your chapter and the media contacts you, who do you direct them to? You should direct them to the Executive Director of the Fraternity. The Executive Director (or designee) shall be the official spokesperson for the Fraternity in response to news media queries, followed by the Grand President. If contacted by news media representatives, you should remain courteous and professional at all times, yet firmly refer questioners to the Executive Director by providing their name and contact information.

#### 16. Identify responsibilities of the Grand Chapter, Board of Directors and Central Office Staff.

The Grand Chapter of Delta Sigma Pi is the supreme body of the Fraternity in which is vested all legislative powers and meets every two years. The Board of Director members are elected to office and provide interpretation of the Laws of the Fraternity. The Central Office is the national administrative headquarters of the Fraternity and coordinates and oversees the Chapter Management Program.

#### 17. What is the difference between a LEAD School and a LEAD Provincial Conference?

LEAD Provincial Conferences are full weekend leadership events focusing on personal, professional, chapter operational and leadership training which includes an awards banquet and Provincial Council meetings during which proposed changes to Bylaws and Ritual are discussed and voted on.

LEAD Schools are leadership events that provide opportunities to build chapter operational, leadership and personal skills in an effective way while also having fun—programming complete on Saturday afternoon.

#### 18. Describe the Delta Sigma Pi Leadership Foundation.

The Delta Sigma Pi Leadership Foundation is the charitable giving arm of the Fraternity. It is a registered 501(c)(3) charitable organization, gifts and donations are tax deductible to the extent allowable by law. The mission of the Leadership Foundation is to financially support educational and charitable programs that enable members of Delta Sigma Pi to achieve individual and professional excellence.

## 19. What differentiates Central Office staff from volunteers such as Board of Directors or Regional Vice Presidents?

Board of Director members and Regional Vice Presidents are elected at Grand Chapter Congress. All elected and appointed Board members and RVPs volunteer their time to the Fraternity and are not compensated. Central Office staff members are hired and compensated employees of the Fraternity.
