



My entire perspective on the fraternity shifted dramatically after those four or five days in New Hampshire. Everyone of the ten Congresses that I have attended has provided innumerable memories and true friendships that make my life richer with each passing year.

So, come to Anaheim to begin or to enhance your personal Deltasig experience. You too can undergo a dramatic shift in your perspective and commitment if you are there and if you let it happen. See you in Anaheim - it will be magical!
