INDUSTRIAL DEVELOPMENT OF NORTH CAROLINA

The history of North Carolina is probably as colorful as any of the 48 states. The first English settlement was made on the outer banks of North Carolina in the year 1584 on Roanoke Island, under the direction of Sir Walter Raleigh. This first settlement was a failure; and to this day the fate of those first settlers is a complete mystery.

The first permanent English colony in North Carolina was established in Albemarle on the Chowan River about 1660 by settlers from Virginia. In 1663, Charles II granted to the Earl of Clarendon and other court favorites a territory which included the present day boundaries of North Carolina.

After the establishment of the first colony at Albemarle, other settlers, chiefly Scotch, Scotch-Irish, and German followed down the valleys from Pennsylvania. Although the life of the colony under proprietary rule during its early years was a turbulent one, the colony grew rapidly. Economic advantages seem to have been the chief motive of colonization. Those economic advantages, which were responsible for the rapid early development of the State, are also responsible for the diversification of industry within the State today.

Nature gave North Carolina easily accessible natural harbors, a favorable climate, good soil, much underground water, abundant mineral supply, and a great deal of nearly level land. The first industrialists took advantage of the natural resources of the State and concentrated their activities on the industries of the open country, viz., farming, animal industries, lumbering, mining, and fishing. Farming remains one of the basic industries within the State. Threefourths of all the flue-cured tobacco grown in the United States is grown in the State. Other important farm crops are corn, cotton, and peanuts. Animal industries are favored in the State because of good all-year grazing, plenty of water, and the finest in feeds, which are obtained from the by-products of its agricultural crops.

There is no state more favored for the lumber industries. Natural reforestation takes place more quickly than in Northern and Western states. Both the mountain lands and the coastal lowlands are available for permanent forest reserves. An abundance of natural water power is available for manufacturing lumber into other products. In addition to pulp wood and paper manufacturing plants, the manufacturing of newsprint from slash pine, which had been considered almost worthless, promises to become an important industry within the State.

Below the fertile soils are found more than 300 minerals and rocks, of which 70 are of commercial importance. The State produces nearly all of the nation's output of kaolin, 70 per cent of the ground and scrap mica, 35 per cent of the feldspar, and is a large producer of tungsten, pyrophyllite, granite, and gravel.

Another industry of the State, which has continued from the days of the first settlement to current times, is that of fishing. This industry includes 25 kinds of food fish, menhaden, and shell fish, all of which are valued at an excess of 16 million dollars annually.

An abundant supply of raw materials, favorable climatic conditions, a reliable supply of native labor, and cheap hydroelectric power has given North Carolina national industrial leadership in the manufacture of textile

goods, tobacco products, and wooden furniture. Other important manufacturing industries are lumber and timber products, flour mills, cottonoil mills, slaughtering and meat packing, chemicals, fertilizer, electronic components, and aluminum.


Some of these industries are as old as the State itself; others are new. A rather new industry is the making of rayon from wood fibre; another is making denatured alcohol for industrial uses from molasses; and still another is the making of paper from yellow pine or from cotton linters. The little gray seed of the cotton, once burned or thrown away, is now a box of blessings. From it comes oil that rivals olive oil and is used in the making of oleomargarine, shortening, soap, and other products. From the cotton linters come guncotton, material for mattresses, rayons, paints, and a great variety of plastic articles.


Discovery of the "flue-curing" method of ripening and coloring bright tobacco in Caswell County, North Carolina, about 1857, boomed the production of this type of leaf, referred to as "Virginian tobacco". Invention of the Bonsack cigarette machine in Durham, North Carolina, in 1884, launched mass production of cigarettes. Today, North Carolina has the world's largest cigarette and cigarette paper factories. Over 52 per cent of the nation's cigarettes are produced in the State.

That the State of North Carolina is the national leader in textile manufacturing, and that it has excellent commercial transportation facilities, probably had much to do with the decision by the E. I. duPont de Nemours and Company, Incorporated, to establish within the State the first plant for the commercial production of "Dacron", one of the most recent of man-made fibres. Production of "Dacron" at this 28 million dollar plant, located 23 miles from Greenville, North Carolina, began in 1953. The

locating of an industry such as this attests to the continuing industrial growth of the State.

No brief discourse on the State of North Carolina would be complete without some mention of the tourist industry. The State's annual tourist income is estimated to exceed 300 million dollars. There are 635,000 acres of game refuge with bear, deer, quail, and rabbit, as well as duck and geese. The streams in the mountains abound with trout; and the coastal waters contain many varieties of game fish. There are 11 national parks and forests and 17 state parks. In addition, there are many historical monuments of state and national prominence. Notable among these historical monuments is Fort Raleigh on Roanoke Island, where the site of the first colony has been restored. At this location, annually, a play is presented as a tribute to the past and as evidence of the faith of the citizens of the State in its future.

left is Reynolds Office Building.




THE R. J. REYNOLDS CIGARETTE PLANT WINSTON-SALEM, NORTH CAROLINA




THE E. I. duPONT deNEMOURS "DACRON" PLANT KINSTON, NORTH CAROLINA



A REVIEW AND SHORT HISTORY OF EAST CAROLINA COLLEGE

East Carolina College, the largest institution of higher learning East of Raleigh, the Capital City, is a co-educational college, situated in the heart of the City of Greenville, North Carolina, maintained by the State of North Carolina for the purpose of giving young men and women such education and training as shall fit and qualify them for professional preparation, and for teaching in the public schools.

Facilities for wholesome living, capably directed extra-curricular activities, and a faculty ranking high in professional preparation provide for balanced college work in an atmosphere of friendly cooperation on the East Carolina campus.

Due to the increased demands for an institution of higher learning, on the part of the people of the eastern section of North Carolina, East Carolina College was authorized by an act of the North Carolina General Assembly on March 8, 1907, as East Carolina Teachers Training School. Ground was broken for the first building on July 2, 1908, and the first regular session opened on October 5, 1909. Only one-year and two-year curricula were offered at the beginning, and the first class was graduated from the two-year curriculum on June 6, 1911.

The College was authorized to offer a four-year curriculum and to confer the Batchelor of Arts degree on November 20, 1920. As a result of the authority to grant a four-year degree, the name of the College was changed to East Carolina Teachers College by an act of the Legislature in 1921. The first four-year degrees were conferred in August, 1922. On August 22, 1929, the College was authorized to grant the Master of Arts degree, and the first such degree was conferred in August, 1933. Later, on May 29, 1941, the College was authorized to offer a curriculum leading to the Batchelor of Science degree. In order to avoid confusion, the name of the College was changed to East Carolina College in April of 1951.

The government of the school is vested in the Board of Trustees, a body of twelve men, appointed by the Governor of the State and confirmed by the Senate. Each appointed member serves for a period of six years or until his successor has been qualified and appointed. CAMPUS

The East Carolina College campus is located on a beautifully wooded 130-acre tract of land in the heart of the City of Greenville, North Carolina, which is one of the largest tobacco markets in the world. At present, there are more than 25 buildings on the campus, including a new million-dollar library, a modern gymnasium with an indoor swimming pool, dormitories for men and women, with two new dormitories under construction, holding over 300 students each. Among others are classroom buildings, a home management building, a college theatre, a faculty apartment-dormitory, a faculty-alumni building, a student union building, and in addition, an athletic field for intercollegiate sports. Plans are now being laid for an out-door theatre.

Due to the critical need of more dormitory and classroom space, the present Legislature has been asked to appropriate over two-million dollars for building improvements on the campus. The most critical need at present is that of a building to house the Business Department. The next

appropriations will be used for this purpose. STUDENT BODY

Enrollment at East Carolina is representative of the State of North Carolina, the eastern part, in particular, and is steadily increasing. In recent years East Carolina has grown from a small college to the third largest state-supported institution in North Carolina, and the fourth largest of all the institutions of higher learning within the State. The fall (1954-55) enrollment totalled over one-thousand freshmen; for the first time in the history of the college the freshmen men outnumbered the freshmen women. The total fall (1954-55) enrollment numbered over 2,700 resident students.

All of the 100 counties of the State of North Carolina are represented in the student body, with the greater number coming from a radius of 75 miles of Greenville. Many of the 48 states and a number of foreign countries are also represented among the student body. Included are two foreign exchange students, one from France and the other from Holland. East Carolina is a fully accredited college and is a member of various accrediting associations; namely,

ORGANIZATIONS

Students of East Carolina are encouraged to affiliate with campus organizations which they feel will help them build character, personality, and scholarship. The campus organizations are carefully selected, and their activities are adequately supervised to make sure the students' needs are being met.

In recent years a growing demand has developed among the students for the establishment of social fraternities and sororities; however, the Administration and the Board of Trustees of the College have held firm against granting admission to such fraternities and organizations. OBJECTIVES

The men and women who have devoted their lives to the advancement and development of East Carolina have set up objectives by which they may guide their policy of administration. If not always obtainable, these objectives reflect the altruistic ideals of these devoted men and women. These objectices are to provide:

- 1. A sufficiently comprehensive acquaintance with, and appreciation of, cultural heritage and the vast body of knowledge needed to help one to live more effectively in a complex world society.
 - 2. A functional philosophy of education and life.
 - 3. A background of knowledge in a given profession or vocation to equip one for a gainful occupation or for further formal education upon graduation.
 - 4. A sterling character, love of fellow man, and such desirable personal traits of emotional stability, sincerity of purpose, initiative, health habits, and effective work patterns, as are needed for home, community, and any other civic or vocational responsibility.

DEGREES

Curricula leading to the Batchelor of Science degree, the Batchelor of Arts degree, and the Master of Arts degree are offered at East Carolina. Also, special courses are offered to provide training in several pre-professional fields; namely, pre-dental, pre-engineering, preforestry, pre-legal, pre-medical, and pre-nursing.

The Batchelor of Science degree is only offered to those students who work toward the teaching degree, while the Batchelor of Arts degree is offered to those students who do not intend to follow the teaching profession upon graduation. In the past few years a great demand has arisen for a non-teaching Batchelor of Science degree. It is expected that this will materialize in the not-too-distant future.

Both the Batchelor of Arts degree and the Batchelor of Science degree are offered in any number of curricula; namely, Art, Business, Chemistry, Economics, English, French, Geography, Health and Physical Education, Home Economics, Industrial Arts, Library Science, Mathematics, Music, Natural Science, Spanish, Social Studies, History, and Sociology. New degrees are being added yearly to meet the growing demand.

Students who graduate from East Carolina, and who have completed the course in Air Force Reserve Officers Training Corps, are commissioned as lieutenants in the Air Force Reserve. Also, students may have an opportunity to apply for the College Officers Candidate Plan, United States Marine Corps, for a commission as a lieutenant in the Marine Corps Reserve.

COUNSELING AND GUIDANCE

Every student entering East Carolina is assigned a counselor to give guidance and counsel in a personal and academic way. An understanding faculty and a cooperative and capable administration are always available. A full testing program is provided for all entering students and is utilized to help them plan their future. CULTURAL BENEFITS

In addition to the concerts, lectures, and play productions provided by the students and faculty members, world-famous artists (instrumental and vocal), bands, symphony orchestras, and lecturers are frequently brought to the campus for the cultural benefit and entertainment of the students and faculty.

FIELD SERVICE

The Field Service of the College is now ten times as large as it was five years ago. Approximately 20 classes are being taught in the various cities of the eastern part of the State, with more classes being requested than the service is able to provide. The enrollment in these classes now numbers about 750. Of these, approximately 350 are service men attached to nearby Marine bases.

LIBRARY FACILITIES

The library at East Carolina is one of the most imposing buildings on the campus. It has accommodations for 600 readers. The building can house over 150,000 volumes and contains general seminar rooms, classrooms and laboratory for library science instruction, a small auditorium, a radio-television studio, and an audio-visual education laboratory, as well as the usual facilities found in modern libraries. The collection now contains a little over 100,000 volumes.

The library's book collection is being increased at the rate of 4,500 volumes per year. East Carolina has been a United States Government Depository since 1951.

CONCLUSION

The foregoing account of the history and development of East Carolina College portrays a growth with both quantitative and qualitative dimensions. In scholarship, standards, curriculum, faculty attainments, and library facilities the college at Greenville is worthy of the highest traditions and standards of the International Fraternity of Delta Sigma Pi.



AUSTIN BUILDING

One of the first buildings on the campus, Austin building, was completed in 1909 and named in honor of Herbert E. Austin, who was a professor in the Science Department and a charter faculty member. This building contains 30 classrooms and a spacious auditorium.



WRIGHT BUILDING

Wright building was completed in 1927, named in honor of Robert H. Wright who was the first president of the college and who held that office for over 25 years.

This building was originally constructed as a combination classroom and gymnasium. Upon completion of the new gymnasium in 1952, renovations were begun on this building to convert it to a Student Union building. To date, approximately one half of the building has been renovated. It is expected that the remainder of this building will be renovated within the next year.



THE INFIRMARY

The infirmary was completed in 1930. It is a two-story building, fire-proof, and is provided with 50 beds.



FLANAGAN BUILDING

Flanagan building houses, among other departments, the department of Business Education. Flanagan building was constructed in 1937 and named in honor of Mr. E. G. Flanagan, who was a member of the Board of Trustees of the College.



SLAY HALL

Slay Hall is a men's dormitory which was completed in 1948 and was named in honor of James Ronald Slay who was head of the Science Department and later Dean of Men. This dormitory will accommodate over 200 men.



THE JOHN CRISTENBURY GYMNASIUM

The John Cristenbury Gymnasium, also known as Memorial Gymnasium, was completed late in 1952, named in honor of John Cristenbury, who was a professor of Health and Physical Education, and who was killed in the service of his country during World War II.

This building contains a gymnasium that will seat in excess of 2,500 spectators, a swimming pool, locker rooms, gymnastic facilities, and classrooms.

THE DEPARTMENT OF BUSINESS EDUCATION

The Department of Business Education was established at East Carolina College in 1936. At that time, there were two instructors. A Batchelor of Science degree was offered to students planning to enter the teaching field. In 1946 a Batchelor of Arts degree was offered; students working toward this degree may major in Accounting or in Secretarial Science. In 1954 a curriculum in Business Administration was added to the Batchelor of Arts program. This curriculum was designed to meet the requirements of the 1955 program plan of the North Carolina Association of Certified Public Accountants. To fulfill the requirements of this curriculum, students must obtain a major in the field of Accounting and a minor in the field of Economics.

At the present time, the Department of Business Education occupies a building which also houses some other departments of the college. Due to the tremendous growth of the department and the fact that the department is now the largest department on the campus, the current legislature of the State of North Carolina has been asked to appropriate funds for the construction of a building which will house only the Department of Business Education. No action has yet been taken by the legislature; however, the administration has placed this building as first on its list of planned permanent additions, and it is hoped that funds will be appropriated during the current year.

Proof of the acceptance of the Department of Business Education at East Carolina College by residents of the State of North Carolina and of surrounding states is attested to by the increase in enrollment in the department. /Enrollment data of the department is presented below:

The increasing demand for the business graduates of East Carolina, within and without the state, serves as evidence of the general acceptance of its high academic standing. Many of the graduates find employment within the state. Those who have left the state have established reputations not only for themselves, but also for East Carolina College.

As a result of continually increasing enrollment in the department, the staff has been increased proportionately. Currently, there are fourteen staff members. Three of the staff have doctorates; and three are Certified Public Accountants. Each of the remaining members of the staff has a Master's degree; and several are continuing their graduate study. It is anticipated that additional faculty members will be added during each of the next several years.

It is believed that the Department of Business Education of East Carolina College will continue to grow as rapidly as dormitory and classroom facilities will permit; but is is the intention of the department never to lower its academic standards merely to meet a quantitative enrollment increase.

HISTORY OF THE DELTA ZETA FRATERNITY OF-EAST CAROLINA COLLEGE, INCORPORATED

In the spring of 1954, a small group of students in the Business Education Department at East Carolina College discussed the possibility of the organization of a professional business fraternity. The leader of this group was Loyd Whitley, first president of Delta Zeta.

Available data on several national fraternities was obtained; and the group unanimously decided that the national fraternity which fulfilled its requirements and which matched the ideals established by the group is The International Fraternity of Delta Sigma Pi. In accordance with the desires of the original group and of subsequent additions to that group, the program of Delta Zeta has been established to coincide as nearly as possible with the requirements of Delta Sigma Pi.

In June 1954, Mr. Homer T. Brewer, Director of the Southeastern Region of Delta Sigma Pi, visited the college campus and met with President Whitley, Faculty Advisor Parker, and twelve-interested students. The keen interest of the group is attested to by the fact that none of the students who met with Mr. Brewer was attending summer school. Each member traveled a considerable distance for the meeting with the regional Director.

At the beginning of the 1954 fall quarter, the original group met and formulated its plans. The first formal meeting of the fraternity was held in the banquet room of the Old Towne Inn in Greenville on September 28, 1954. Since that time meetings have been held regularly in the same location on the second and fourth Tuesday nights of each month.

During the balance of the 1954 year all meetings of the fraternity were devoted to business of the fraternity and its organization. The fraternity was incorporated under the laws of the State of North Carolina on November 15, 1954. At a meeting held on November 18, 1954, the members of the fraternity unanimously voted in favor of petitioning The International Fraternity of Delta Sigma Pi for a charter.

Beginning in 1955, the fraternity decided to reserve the first meeting in each month for a business meeting and the second meeting in each month for a professional program. In January, Mr. William Wright, Chief Accountant of the Kinston "Dacron" plant of the E. I. duPont deNemours & Company, Incorporated, spoke to the members. His subject was "The duPont Company's Cost Accounting System." Mr. Richard Worsley, Certified Public Accountant, Greenville, addressed the fraternity in February, using as his subject "Personality Requirements of Persons Entering the Fields of Accounting."

In October 1954 the fraternity sponsored a contestant for homecoming beauty queen. A smoker was held for members in January 1955. The fraternity has completed arrangements for a dinner dance to be held at the Greenville Country Club in March.

Members of the fraternity decided to defer rushing until grades for the winter quarter had been determined. It is anticipated that a rush week will be held in the third or fourth week of March.

Several activities are being planned by the fraternity. Arrangements have been made for an Internal Revenue Agent to be on the campus in March

for the purpose of aiding students and faculty members in the preparation of their income tax returns. Plans have also been formulated for the members of the fraternity to tour the manufacturing plants of the R. J. Reynolds Tobacco Company, Winston-Salem, North Carolina. This tour is being planned for the month of April; but the exact date has not been settled with the Reynolds Tobacco Company.

The visit on the campus by Mr. Thomson, Executive Secretary of Delta Sigma Pi, is eagerly anticipated by the members of the Delta Zeta Fraternity.






