# HISTORY OF CENTRAL MISSOURI STATE UNIVERSITY

The Central Missouri State University in Warrensburg,
Missouri, was founded as the State Normal School for the Second
Normal District of Missouri on May 10, 1871, in pursuance of
the Normal School Act passed by the General Assembly of
Missouri on March 19, 1870. A commission appointed by the
governor decided that the school would be located in
Warrensburg, Missouri on April 27, 1871.

George Petrie Beard served as the first president from 1871 to 1872, followed by James Johonnot (1872-1875). The first years were difficult ones. An interest had to be aroused for an institution devoted to the training of teachers. Under such circumstances, it was quite natural that the legislature should make meager appropriations for the support of this school. Securing proper equipment and staff was a difficulties that were encountered, the first decade, 1871 to 1881, showed an average enrollment of 381 students. Enrollment steadily grew so that in the decade from 1901 to 1911 the average annual attendence reach 1,460.

A disastrous fire occurred on March 6, 1915, destroying the main buildings. The spirit and loyalty of the students and faculty was such that school sessions were immediately resumed, being held in temporary quarters until the buildings could be restored. E.L. Hendricks, elected president March,

1915, began the task of rebuilding the school.

The name of the school was changed from the Warrensburg Normal School to The Central Missouri State Teachers College. The school was accredited as a four - year teachers college in 1915 and was officially recognized by the General Assembly as The Central Missouri State Teachers College on May 20, 1919. On February 5, 1922, CMSTC became The Mules, using the Missouri mule as their mascot.

Permissive state legislation in 1945 enabled the school to become the Central Missouri State College on July 1, 1946. Dr. Warren C. Lovinger became the college's tenth and present president in the Fall of 1956. In August, 1972, state legislation was passed enabling the college to become Central Missouri State University.

Central Missouri State University is accredited by the North Central Association of Colleges and Secondary Schools. For Fall 1978, 9249 students have enrolled at CMSU.

# A HISTORY of the DEVELOPMENT of the SCHOOL of BUSINESS and ECONOMICS at CENTRAL MISSOURI STATE UNIVERSITY

The Business Administration Department of CMSU was planned in the spring of 1946 and inaugurated in the year 1947. We have now celebrated our silver anniversary. Prior to that time, the chief objective of the business department was to train teachers to enter the field of business education. The faculty consisted of two people:

Mrs. Mildred Lass and Miss Ruthetta Krause, with Dr. Lucas Sterne being brought in to head the department in the fall of 1946. The catalog of that year showed the Departments of Business and the Department of Economics housed together in the Administration Building.

The Economics Department was offering such courses as marketing, business organization, retail merchandising, as well as the usual courses in economics. Dr. Royal Briggs served as the head of the Social Studies division, which included the departments of history, sociology, religious education, political science, as well as economics and commerce.

The curriculum consisted of 19 courses which were taught in the Administration Building. During the war, there had been much post-war planning, and it was decided that the Commerce Department should be moved to the newly formed Applied Arts Science Division—the reason being that Business Education was primarily vocational, and, therefore, should be moved to join the other departments offering vocational education, such as agriculture, home economics, and industrial arts.

The enrollment of some 60 students included many war veterans who expressed a desire, during the enrollment procedures, to take two years work that would enable them to finish a four-year program in business at some other institution. Thus, the need for a four-year program became evident as we began to know our students.

In the spring of 1948 we witnessed our first graduating class.

Hubert Madison—an accounting major, all by himself. The numbers increased so rapidly to the point that we were graduating nearly 1/4 of all graduates.

We had enough confidence in our program that we felt all our students needed a chance to prove their worth. A contact with Harvey Stover, then managing partner of Arthur Anderson and Company, resulted in a relationship which still exists today--namely, the internship program, whereby our senior students would work for their firm during the winter quarter. The program was so successful that soon our students were receiving job entries in such cities as New York, Chicago, St. Louis, Houston and Omaha. After a period of several years our internship program was expanded until we now enjoy relationships with practically all of the leading national firms.

It was not until 1953 that the Department of Business inaugurated a graduate program. This program was specifically designed for the business teachers. The year of 1958 saw us increasing in status by the fact that we became a full division and were moved into Dockery, which we were to share with the English Department. By 1960 a Master of Arts was offered, thus recognizing the need for a higher preparation for those entering the business world. As a result of this new program, the opportunity arose to offer graduate assistanships to some of the interested students.

Whether the cause was our ability to offer graduate assistanships or graduate students being exempt from the draft, at any rate, our graduate program more than tripled in enrollment during the year 1965. Graduate programs were also established at Whitman Air Force and in Kansas City which were designed to serve their special needs.

Crossing another milestone, a School of Business Administration and Economics came into being on June 1, 1969, with Dr. Robert Pierce as the new Dean. Dr. Sparling was appointed as chairman of the division beginning July 1, 1965 and one year later resigned to accept the position as Comptroller of the college. Dr. Dale Blackwell was appointed as: Chairman of the division and Dr. Charles Kuhn began his service as coordinator of the Graduate Program. We are most fortunate to have a faculty woth a genuine interest in their students, willing to go a second mile to occupy the role of teaching.

WARRENSBURG, MISSOURI

Take an old hound dog named Drum, add a bunch of Missouri mules, sprinkle with community pride and Civil War history, surrond with fertile farmland, add a university, a state park and a large military installation—and you have a perfect setting for the thriving West—Central Missouri city of Warrensburg, county seat of Johnson County.

Although the city of Warrensburg celebrated its hundredth anniversary in 1955, the community actually had its beginning when
Martin Warren arrived from Kentucky in 1833 and built a log cabin.
Mr. Warren's cabin became the nucleus of a settlement, principally
because it was located on a well-used Osage Indian trail that wound
northward to the Missouri River, and within three years the township
of Warrensburg was organized. The town was incorporated in 1855,
the date commemorated by the centennial celebration.

Missouri was one of the first states west of the Mississippi to promote the building of the new-fangled railroads, and as early as 1851 the first surveys for the Pacific Railroad were started west-ward from St. Louis. The selection of the route of the new rails became an important issue for Warrensburg, for the coming of the railroad could mean new settlers, markets for farmers, and booming business for merchants.

In less than a decade the railroad had made possible a major Warrensburg industry, the quarrying of sandstone. A two-mile branch line ran northward from Warrensburg to serve quarries, and in 1873, a total of 1,400 carloads of stone was shipped to St. Louis.

Warrensburg has two active newspapers, The Standard-Herald and The Journal, both of which were established two months apart at the close of the Civil War. The Journal could point to 48 years of continuous publication when it was consolidated with the Star in 1913 to form the Daily Star-Journal, now Johnson County's only daily paper.

From a population of 4,600 in 1910, Warrensburg had grown to over 11,000 half a century later, and now is approximately 14,000.

Two new elementary schools and a new \$800,000 senior high school have been constructed in the past few years. 1972 was the date the Warrensburg school district opened its new Vo-Tech facility. The Vo-Tech School offers courses in auto mechanics, welding, carpentry, office machines, practical nursing, and distributive education.

Warrensburg is the county seat of Johnson County. The 34,000 inhabitants of the county are comprised mostly of a thriving agricultural community, but also include the communities of Holden, Knob Noster, Leeton Kingsville, Centerview, and Chilhowee. Whitman AFB also is in Johnson County, and the facilities of state and federal government are available to the personnel of Whitman through these agencies located in Warrensburg.

Among Warrensburg's newest public building is the Johnson County Memorial Hospital. The new structure, built on a 15-acre site at the east edge of the town, provides the latest in medical care, has a capacity of 100 beds, and is one of the best and complete facilities in the state.

With over 67 acres of improved parks, Warrensburg is popular with Whitman AFB personnel. The largest park is Grover Memorial Park, which has lighted baseball fields, tennis courts, swimming pool and

complete picnic and sanitary facilities. Near the business district is the well planted and maintained Shepard Park. For the youngsters, the recreation committee of the park board has developed a well-rounded summer recreation program, running the gamut from sewing and ceramics to story telling and smallfry baseball leagues.

The Warrensburg Saddle & Bridle Club has an active program inecluding an annual horse show on club-operated show grounds. Fishing is enjoyed at Pertile Springs, Tackett Lake, Lions Lake, Black Water River, and several small streams nearby.

When Senator George Graham Vest paid his famous tribute to the dog in the Old Court House in Warrensburg, Mo. in 1870, he appealed to the hearts of dog lovers everywhere when he said, "The one absolutely unselfish friend that a man can have in this selfish world, the one that never deserts him, the one that never proves ungrateful or treacherous, is his dog."

That Eulogy of Senator Vest won the case for Charles Burden whose favorite hound, Drum, was shot by a neighbor, Leonidas Hornsby, who had sworn to kill the first dog that came on his place after he had lost a number of sheep. Though Hornsby had hunted with Drum, and ackowledged him to be one of the best hunting dogs he had ever seen, he stubbornly insisted on carrying out his threat when one dark night a dog was found prowling in his yard. That dog was Old Drum.

Immediately Burden sued Hornsby for damages and the trial became one of the strangest in the history of this section of the country.

Each man was determined to win his case and several appeals were made till Hornsby finally took it to the Supreme Court of Missouri. Burden, however, was awarded \$50 damages for the loss of his favorite hunting dog, Drum. West's Eulogy to the dog, which he made in his final appeal to the jury, won the case and became a classic speech.

Through the direction of the Warrensburg Chamber of Commerce, and the coordinated efforts of many dog lovers, over the country, Old Drum was immortalized in a statue on the Johnson County Courthouse lawn, in Warrensburg, Mo., September 23, 1958. Dog lovers all over the country responded quickly to the national announcement of the placing of this statue to Old Drum, who has become a kind of symbol of all dogs that

people have loved.

When Senator Vest said, "Gentlemen of the jury, a man's dog stands by him in prosperity and poverty, in health and sickness", he touched a common bond of relationship in all dog lovers.

The prospect of forming a professional business fraternity at Central Missouri State University was presented by John A. Watton, a former member of the staff at The Central Office of Delta Sigma Pi, to Dr. Robert B. Pierce, Dean of the Business School, in July 1978. Dean Pierce gave John Watton permission to work on establishing a chapter and also said he would be willing to help. Dean Pierce then sent John Watton to the Vice President for Student Activities, Dr. Tom Edmonds, to find out about the requirements for establishing an organization on campus. John Watton was informed that a petition needed to be submitted which included such items as the objectives of the organization, proposed constitution and bylaws, membership requirements, and membership dues and assessments.

John Watton then went to visit Dr. Charles Drake, a faculty member, who is an alumnus of Delta Sigma Pi. Dr. Drake also expressed an interest in establishing a chapter, and he agreed to help get the process on the way.

By posting notices on bulletin boards, putting notices in the campus newspaper, the Muleskinner, and making announcements in business classes, students found out about the idea of establishing a chapter. The first organizational meeting was held September 13, 1978, at which there were 19 students in attendance. At this meeting information was given about the fraternity.

One week later, on September 20, 1978, the second meeting was held in order to organize the fraternity. The first step was to choose a steering committee which consisted of eight members. During the rest of the meeting the idea of recruiting at the activities night, which was to be held in the Student Union, was discussed.

The following night the steering committee met to discuss the activities night. Due to the fact that the group was not a recognized organization on campus, participation in activities night could not take place. This

lead to the appointment of a committee to draft a set of bylaws. The committee, assisted by John Watton, consisted of three members - John Harmsen, John Virgo, and James Owens. In discussing the various aspects required, a set of bylaws were written according to the manual provided by The Central Office.

Within this time, John Watton discovered that there was another Deltasig on the faculty, Major Peter F. Watkins, an alumnus of Eta Omega Chapter.

Major Watkins is the Army ROTC recruiter on campus. He also expressed a strong interest in helping establish a chapter on campus.

As a result of the next meeting, on September 28, 1978, the name Chi Mu Sigma was adopted, because it corresponds with the university's name, CMS. The Executive Director of Delta Sigma Pi, Ben H. Wolfenberger, had suggested this name to John Watton a week earlier.

To organize the group further, the meeting of October 9, 1978, was set aside for election of officers. The election results were as follows:

Two advisors were also chosen for the chapter, Dr. Charles Drake and Major Peter Watkins. The group in attendance then unanimously passed a motion to petition the International Fraternity of Delta Sigma Pi for a chapter charter.

On October 11, 1978, an executive committee meeting was held, and several different activities were discussed. Senior Vice President,

John Virgo, was put in charge of planning for a Winter recruiting program

and setting up a public relations campaign. The treasurer, Gayle Kral, was assigned the job of opening a checking account. The secretary, Stacy Rogers, and the President, John Harmsen, were put in charge of drafting a letter to be sent to The Central Office stating that Chi Mu Sigma voted to petition the International Fraternity of Delta Sigma Pi for a chapter charter.

At the November 2, 1978 meeting, an announcement was made by
Gayle Kral that a checking account had been opened at the United Missouri
Bank of Warrensburg. Also, John Harmsen announced that the letter to
The Central Office was ready and would be mailed the following day.

The meeting of November 6, 1978, was set aside to finalize the plans for the recruiting program. The decision was made to use a recruiting table, classroom announcements, and posters. Also, Senior Vice President, John Virgo, composed and sent 600 letters to prospective members.

At this meeting a new Vice President for Professional Activities had to be appointed. Larry Walsh resigned from this position, so Anne Davis was elected to fill the position.

After the meeting, the group met for a social activity at a local pizza parlor. This brought the members together and helped them to understand a little more the meaning of the fraternity.

Everything seemed to be going well for Chi Mu Sigma. The Administration had helped in many ways - teachers had showed their support by helping out and a bulletin board had been assigned to Chi Mu Sigma in the Business School, Dockery Hall. Also, the Student Government Association had voted in Chi Mu Sigma as a recognized organization on campus.

With the recruiting program on the way, a "Meet the Chapter Night" was scheduled for December 4, 1978. The function was held in the university's Alumni Chapel. The recruits in attendance totalled 105, which was better than expected. During the function, the prospective members

were given information on the fraternity and how the fraternity could help them as business majors.

The next activity was scheduled for the following week, December 12, 1978, in the University Student Union Conference Center. The guest speaker, Dean Robert B. Pierce, gave a speech on how extra-curricular activities are important in the development of a business executive. This meeting also had a good attendance of 60 students. This was the last activity held before classes were dismissed for the Holidays.

After the Holidays, on January 5, 1979, a social activity was held at the Johnson County Community Center. This activity allowed the prospective members to meet one another. This was also the night when recruits were asked to pledge Chi Mu Sigma.

The following week marked the start for the pledge program. The first night, January 10, 1979, the pledging ceremony was held in the Alumni Chapel. At this time, 52 pledges were pinned and also received pledge manuals.

Within the first few weeks of pledge, two executive positions had to be filled. Stacy Rogers had resigned her position as secretary after the first term. The newly appointed secretary was Susan Hinck. The historian, Lee Ann Romano, also resigned her position. The position of historian was filled by Pat Donovan.

Throughout the pledge program, the pledges were instructed by Vice President of Pledge Education, Rich Michaels. The pledges were also given presentations by several of the officers on different aspects of the fraternity. At one of the meetings, pledges were given the opportunity to sign up for a committee of their choice. This was one way to get everyone involved in the fraternity.

During the pledge program, pledges were also responsible to host a

Professional Speaker Night and to hold a fund raising drive. The Professional

Speakers night was scheduled for February 13, 1979, but, due to finals and term break, it was rescheduled for March 20, 1979. Mr. Lynn Harmon from the Citizens Bank of Warrensburg will serve as the professional speaker.

The fund raising drive began on February 14, 1979. Funds had accumulated from individual organizational fees of 50 dollars but were reduced because of National Fees. Because more money was needed for upcoming events and to establish a reasonable checking account the fund raising committee, headed by Mike Adams, initiated a fund raising promotion in which each member participated to raise money. The ending balance amounted to 1200 dollars.

At the last pledge meeting, on February 14, 1979, the Assistant Executive Director of Delta Sigma Pi, Michael J. Tillar, visited Chi Mu Sigma. He spoke about The Central Office, The Grand Chapter Congress, and Chi Mu Sigma's installation day. This was a very informative meeting and helped everyone to understand more about the fraternity.

With pledging activities out of the way, Chi Mu Sigma went inactive for finals and term break. Over term break, eight members of Chi Mu Sigma went to the Regional Conference in Oklahoma City, Oklahoma. The members who participated in the conference include: Dana Graham, Amy Grothaus, Bernie Irman, John Pottier, Anita Rincker, Cindy Schepers, John Virgo, and Brad Young. During the conference, information was obtained concerning fraternity operations. This information will go toward improving Chi Mu Sigma in the future.

Meanwhile, Chi Mu Sigma is waiting for April 28, 1979, the day set aside for installment. Other activities have been planned for the spring term which will keep the members busy and to help the fraternity become better known. The first Spring Class Pledge Meeting is scheduled for March 28, 1979, a Professional Speaker is planned for April 3, 1979, and with these activities a field trip and a social activity are planned.
