



In November, 1966, the Missionary Society of the First Congregational Church of Washington, D.C. decided to establish a school of the elevation of the "freedmen" who were annually pouring into the city by the thousands.

The first draft of the charter provided for a college only; the next draft, for a university.


The University was founded in 1867 by General Oliver Otis Howard. Its first building was the School of Religion and Theology. From that single frame building, Howard University has grown to a campus of 75 acres with buildings and equipment valued at more than \$95 million dollars. There are separate classrooms and laboratory facilities for each major discipline.

The University Library, Founders Library, houses 952,919 bound volumes, 7,303 periodical subscriptions, a media center, and the Moorland-Spingarn Research Center, which has the largest collection of Black literature in the United States. Howard University also operates two radio stations; WHUR, which functions on a 24-hour basis, and WHBC.

The faculty consist of 305 full-time professors, 279 associate, and 652 assistant professors. Howard University has seventeen schools and colleges; the Schools of Architecture and City Planning, Business and Public Administration, Communications, Education, Engineering, Human Ecology, Law, Religion, Social Work; Colleges of Allied Health Sciences, Dentistry, Fine Arts, Liberal Arts, Medicine, Nursing, Pharmacy and Pharmacal Sciences; the Graduate School of Arts and Sciences. The University offers bachelors and masters degrees in various disciplines and doctorate degrees in Philosophy, Education, Ministry, Social Work, Pharmacy and Medicine.

Howard University is a coeducational, private institution of higher learning located in the northwestern section of Washington, D. C. close to many cultural and historic institutions.

SCHOOL OF BUSINESS AND PUBLIC ADMINISTRATION



In 1869, the local community surrounding Howard University submitted a petition to the University's Board of Trustees seeking to establish a commercial school in the District of Columbia. The purpose of the school was to educate minorities in commercial and financial matters. Reacting to the needs of the community, the Board of Directors promptly decided to approve the opening of the first School of Commerce at Howard. On January 18, 1870, the School of Commerce was established, later to become known as the School of Business and Public Administration.

Howard University's first Commercial School operated for four years in conjunction with the old Freedmen's Savings Bank and Trust Company. After the bank closed, the School was discontinued until 1903 when it was reopened to offer college - level courses leading to the Bachelor of Science degree. Two years later, the School's status changed to that of secondary level. This arrangement continued until the establishment of the School of Commerce and Finance in 1919.

In January of 1970, the Board of Trustees approved the founding of the School of Business and Public Administration, and authorized the founders to admit the first class in September of the same year.

The primary objective of the School of Business and Public Administration is to prepare its students for high-level managerial positions in business, government and non - profit service institutions such as hospitals and health maintenance organizations.

The School offers undergraduate education and , since 1972, a graduate program in business as well.

The undergraduate curriculum provides for concentration in the areas of finance, accounting, international business, management, marketing, computer - based information systems and insurance. Upon completion of the program, the Bachelor of Business Administration degree is awarded.

Under Dean Milton Wilson, the faculty designed a curriculum with the following thoughts in mind: adaptability, flexibility, perception, and understanding coupled with the ability to analyze and critique through objectivity.


Currently housed at 2345 Sherman Avenue N.W., Washington, D.C., the School of Business and Public Administration has an enrollment of 1,100 students from all parts of the United States and abroad. It is the fastest growing School on Howard University's campus.

A vital component of the University, the Schoool is accredited by the Middle States Association of Secondary Schools and Colleges. The undergraduate programs are accredited by the American Assembly of Collegiate Schools of Business and the graduate program is on the agenda for accreditation in June of 1980.

During the spring semester of 1979, Mr. Michael J. Tillar, Assistant Executive Director of Delta Sigma Pi, along with other alumni of the fraternity visited. Howard University here in Washington, D.C. They came to acquaint interested students in the School of Business and Public Administration with the Delta Sigma Pi Fraternity.

As the academic year progressed the students conducted a meeting for the election of officers:

In the fall semester of 1979, the following elections took place:

The eager pledge class began its activities by participating in the preparation for "Careers Exploration Day." There were various duties to be filled ranging from blowing - up balloons, creating promotional posters and hosting. On October 4, the pledge class sponsored Mr. Chuck Pryor, Senior Marketing Representative of Delta Airlines. Mr. Pryor discussed the operation within the corporation and he also presented a film. It proved to be informative particularly for students seeking a major in management. During the remainder of October, the pledgees sponsored two bake sales to generate additional funds for the budget. The pledgees were urged to contribute goods as well as money and to promote the affairs with enthusiasm. Both of the sales were very successful, contributing to the growing unity and professionalism within the pledge class. Ending the month of October, the pledge class featured Dr. John L. Holmes, a Marketing Representative of the Exxon Oil Corporation. The group was enlightened by an informative description of the managerial structure of "Esso Internationale", various technological advances is petroleum production, and the avenues for employee advancement.

The pledge class began the November activities with a forum hosting Ms. Daisy Lewis speaking on the "Real Estate Industry of the District of Columbia." Ms. Lewis has been in the real estate business for twenty year and is currently the President of the National Association of Negro Business and Professional Women's Club. She spoke of the decline of industry in Washington due to the increasing mortgage interest rate along with what takes place in a real estate transaction. On November 11, the pledge class sponsored Mr. T.M. Alexander, "The Insurance Wiz", in a candid discussion on various insurance tips and the first Black pioneers in the Insurance Industry. The group was overwhelmed by his rich cache of inspiring, poetry and hope for the future. the period from November 16th through the 20th was devoted to collecting clothes for the annual Thanksgiving Clothing Drive. This interaction with the Howard University community. The following week, the pledge class visited Merrill

Lynch Brokerage Firm for a tour conducted by Ms. Reina Duvall. Ms. Duvall spoke mainly of the top-level managerial positions in the firm and described the nature of the stock market as it related to the nation's economy. On November 19, the class sponsored its last professional speaker to date; Mr. Jack Guerin of Uniworld Advertising Agency. Mr. Guerin discussed the role of advertising in business and the competitiveness among agencies.

The pledge class rounded out all activities with an evening of relaxation on November 29. The annual "Thursday Evening Affair" allowed pledgees the opportunity to assemble before the Christmas break, celebrate the successful sponsoring of activities for the semester, wish each other a Happy Christmas and New Year and plan to return next semester for continued dedication and service to Delta Sigma Pi.
