About Baruch College

Baruch College, formally known as Bernard M. Baruch College, is a public university located in the heart of the Flatiron district in New York City. Baruch is one of the senior constituent colleges of the CUNY (City University of New York) system. The College has three undergraduate schools: the Zicklin School of Business, the Weissman School of Arts and Sciences, and the School of Public Affairs.

History

Baruch College began its humble roots in 1919 as the City College School of Business and Civic Administration, as part of the Free Academy. The Free Academy's mission was to support students who wanted higher education, but could not afford to enroll in New York City's private universities.

The College became co-ed in the 1930s and enrollment reached 1,700 day session students in 1935. The majority of the student body was Jewish and Italian immigrants. In 1958, the College changed its name to honor one of the more notable alumnus, Bernard Baruch, a successful businessman and financier.

Bernard Baruch (August 19,1870 - June 20,1965) was born of German and Jewish descent in Camden, South Carolina as the second of four sons. He and his family moved to New York City in 1881 and Bernard graduated from the City College of New York in 1889. From there, he became a successful broker and subsequently a partner in A. A. Housman and Company.

During World War I, Baruch was the advisor to President Woodrow Wilson on national defense issues and served as the chairman of the War Industries Board. During World War II, he was a presidential consultant on economic issues and brought up proposals dealing with a tax-withholding plan, rent ceilings, and a synthetic rubber program.

In 1946, President Harry S. Truman appointed Baruch as the United States representative to the United Nations Atomic Energy Commission where he proposed a system of international regulations and inspections to eliminate nuclear weapons.

Baruch College Under the CUNY System

In 1968, Baruch College became a senior college in the City University of New York system. Former federal Secretary of Housing and Urban Development Robert C. Weaver became the first president of the new college from 1969 to 1970. In 1971, Clyde Wingfield was named college president, followed by Joel Edwin Segall in 1977. Current CUNY Chancellor Matthew Goldstein's term was from 1991 to 1998.

Under Kathleen Waldron's presidential leadership from 2004 to 2009, the college received alumni donations of \$25 million from William and Anita Newman, \$10 million from Lawrence and Eris Field, and \$2.5 million from Martin Antonowsky.

Accreditations and Memberships

Baruch College

- Baruch College's Zicklin School of Business and its Stan Ross Department of Accountancy have maintained their accreditation with The Association to Advance Collegiate Schools of Business (AACSB) International, a distinction earned by less than 5% of the world's business schools.

- From more than 2,300 schools surveyed by Entrepreneurship magazine and The Princeton Review, the Baruch College undergraduate program in entrepreneurship was ranked #9 in the nation.
- In 2009, Forbes ranked Baruch College #35 in Best College Buys, #59 in Best Public Colleges, and #304 in America's Best Colleges.
- Baruch College ranked #36 overall in its list of best master-degree granting institutions in the north, and #6 among best master-degree granting public colleges in the region. (U.S. News & World Report, "America's Best Colleges 2010").
- Baruch College, with an acceptance rate of 23.5%, was named the most selective college in its region. Baruch also retained its place in rankings for ethnic diversity of the student body, coming in at #1 for the eleventh year in a row (U.S. News & World Report, "America's Best Colleges 2010").
- Baruch College was named one of best 371 colleges by The Princeton Review in The Best 371 Colleges: 2010 Edition placing Baruch among the top 15% of U.S colleges.

Zicklin School of Business

Baruch offers undergraduate and graduate programs through its Zicklin School of Business, the only CUNY school that offers business programs accredited by the



AACSB, representing the highest standard of achievement for business schools world-wide.

- From more than 2,300 schools surveyed by Entrepreneurship magazine and The Princeton Review, the Baruch College undergraduate program in entrepreneurship was ranked #9 in the nation in 2009.
- Baruch's undergraduate accounting program was ranked 20th in the nation by Public Accounting Report's Annual Survey of Accounting Professors. The Zicklin School's graduate accounting program was ranked 22nd in the nation.
- Baruch's undergraduate business programs ranked 41st nationally, the second most highly regarded in the NY/NJ metropolitan area. The undergraduate business program was also ranked among the top 25 of public institutions (*U.S. News & World Report*, "America's Top Colleges 2008").
- Baruch's Part-Time MBA Program is ranked 22nd in the nation by U.S. News & World Report ("America's Best Graduate Schools 2009"), making it second in New York City. It was the only ranked public part-time program in New York State.
- Baruch's Zicklin School of Business is included in the 2007 edition of *The Princeton Review*'s annual "Best Business Schools" listing.
- The 2006 edition of the Wall Street Journal/Harris Interactive Business School Survey ranked Baruch 50th among the nation's top 50 regional undergraduate business colleges.

The Baruch College Master's degree program in Financial Engineering has been ranked among the top ten in the 2009 QuantNetwork Ranking of Financial Engineering/Mathematical Finance MS Programs in North America.


School of Public Affairs




History of the Zicklin School of Business

In 1968, Baruch became an independent senior college offering the only AACSB accredited business programs within CUNY. It has since grown to become the largest collegiate school of business in the nation.

The Zicklin School offers degree programs leading to the BBA, MBA, Executive MBA, MS, Executive MS in Finance, and the Baruch/Mt. Sinai MBA in Health Care Administration, which is accredited by the Accrediting Commission on Education for Health Care Administration (ACEHSA). Among its exciting new initiatives are the Zicklin Full-Time MBA program, which enrolls a select group of candidates whose credentials and average GMAT scores of 650 place them among the top students in the nation. Its combined, five-year under-graduate/MS degree program in accountancy meets the latest education requirements for the CPA exam. The Zicklin School houses the City University's PhD in business and offers a joint degree program leading to the JD/MBA degrees in conjunction with both Brooklyn Law School and The New York Law School.

In 1998, the Zicklin School of Business was named in appreciation for a generous endowment from alumnus and financier Lawrence Zicklin, class of 1957, and his wife, Carol.

Marketing Resource Lab

The lab is a faculty-directed, student-run resource center that supports student learning in the areas of advertising, direct marketing, and marketing research. It seeks to accomplish its mission by enhancing information literacy through student training in the use of marketing software and databases, and by helping students gain practical experience in solving real-world problems with independent study projects and marketing competitions.

Field Center for Entrepreneurship

The Field Center provides educational programs, a networking environment, and consulting help for small and start-up businesses. The Center links Zicklin School of Business faculty and students with these entrepreneurs. Faculty members participate in the Field Center's programs in accounting and taxation, banking and finance, management and human resources, marketing and promotion, and technology assessment.

Wasserman Trading Floor and Subotnick Financial Services Center

The Subotnick Center is the only business school resource of its kind in New York and one of a handful of comparable facilities at top educational institutions nationwide. Its centerpiece is the Bert W. and Sandra Wasserman Trading Floor, a fully equipped, simulated trading environment featuring 42 high-end networked computer workstations, continuous live data feeds, real-time market quotes, and computerized trading models.

Robert Zicklin Center for Corporate Integrity

The Robert Zicklin Center for Corporate Integrity (CCI) keeps an informed spotlight on the changing issues of governance and financial reporting confronting U.S. corporations



and capital markets. CCI, formerly the Center for Financial Integrity, sponsors research and convenes opinion makers in business and public policy to advance its goals through lectures, round tables, and conferences.

Weissman Center for International Business

The Weissman Center for International Business sponsors numerous programs, conferences, and forums for students, faculty, and business professionals that enrich understanding of critical issues in international business and the global economy. With guidance from an advisory council of distinguished executives, the Center builds bridges between the worlds of academia and international business.

Center for the Study of Business and Government

The CSBG provides economic analysis that seeks to sharpen and inform public decision-making. The Center has made notable contributions in areas such as welfare reform, health policy, labor market policies, Social Security reform, federal budget issues and monetary policy and inflation.

STARR Career Development Center

The mission of the Starr Career Development Center is to provide comprehensive career services to Baruch College undergraduates and to Weissman graduate students. They encourage students to come to the Center from the time they are freshmen through senior year graduation and for selected career services as alumni. The staff of the SCDC is dedicated to assisting students in all aspects of their career development as they make decisions about majors, apply to graduate and law school, prepare for internships and jobs, and develop the soft skills necessary to become successful in their chosen future careers.


Baruch College Student Demographics






Ethnicity




Gender






Enrollment Status

History of the Delta Phi Omega Colony of Delta Sigma Pi

The Delta Phi Omega Colony of Delta Sigma Pi was founded in November 2009 by Johnson Ma, Dorothy Kyi, and Michael Kang. Johnson had originally attended Binghamton University and rushed with the Kappa Lambda Chapter of Delta Sigma Pi there. Impressed with what he saw, he wanted to join Delta Sigma Pi when he transferred to Baruch College Fall of 2009. Unfortunately, there was no chapter established here at Baruch, but he was encouraged by the brothers he had met from Kappa Lambda to start a colony. With the encouragement from brothers of Kappa Lambda chapter and the help from a co-worker who was a close friend of an administrator at Student Life, Johnson decided to start a colony at Baruch College.

Johnson contacted Dale Clark in September 2009 with the prospective of starting a new colony at Baruch College. Dale Clark was very excited to hear about the opportunity of expanding the fraternity to include CUNY Baruch College. Johnson kept in constant contact with Dale with any new updates and guidance from Dale. Johnson introduced the prospect of starting Delta Sigma Pi to Dorothy Kyi since they were close friends and also had mutual friends who were part of Kappa Lambda chapter. With some encouragement from their mutual friends, Dorothy Kyi quickly joined Johnson in the efforts of starting a colony.

Around the same time, Gary Chang, who recently crossed at Alpha Chapter introduced the prospect of starting a chapter of Delta Sigma Pi to Michael Kang at Baruch. Gary Chang also happened to also be a close friend of both Johnson and Dorothy having gone to Midwood High School together for four years. When Gary learned about Johnson and Dorothy's efforts of starting a colony of Delta Sigma Pi at Baruch, he told them he knew a friend who was interested in started Delta Sigma Pi as well. The following week, Gary set up a dinner and introduced Michael Kang to both Johnson and Dorothy. They've been working together since then to help bring the values of Delta Sigma Pi to Baruch. With the joint efforts of Johnson, Dorothy and Michael and the approval from Student Life, Delta Phi Omega was officially founded on



November 18, 2009.

Gulam Chowdhury, a friend of Michael Kang, quickly join the three after learning about what Delta Sigma Pi was and their goals. Driven by the common goal of bringing a prestigious professional fraternity that the school has never seen before, these four students grew close to each other and were determined to bring Delta Sigma Pi to Baruch College. Michael Kang worked closely with the school administrators as Johnson worked with Dale Clark and the Central Office.

The four invited all their friends to join and support the development of the fraternity, and soon it had gained enough popularity within the student body to set up information sessions. The first information session was held after finals of the fall term with the help of the Alpha chapter. Even though the school was closed, more than 30 people showed up.

After the information session, membership grew from 4 to about 20, and new executive committee members were voted in. Elections for Chancellor, VP of Community Service, VP of Professional Events, and Historian added Wilson Luo, Jason Lee, Alexander Tsoi, and Helen Li respectively to the executive committee. Over the winter vacation of the same year, these eight students met to discuss long-term strategies that would increase membership, finance the expansion, and organize events that would increase publicity. Without the funds to finance the events, the support of a large membership base, or the experience of setting up a large organization, the executive committee faced a difficult challenge for the spring of 2010.

The next step that the executive committee took was setting up professional and community service events to facilitate recruiting opportunities and to attract students from all classes and business majors. To do so, Alexander contacted many business-affiliated clubs in Baruch in hopes of developing a strong relationship with them; hence Delta Phi Omega was often one of their primary choices for professional event collaboration and sponsorship. In the meantime, Jason and his assistant, Jenny Tan,



reached out to non-profit organizations and set up community service events where members could volunteer their time.

Some clubs that the colony worked with in the spring semester are the Baruch College Accounting Society, Beta Alpha Psi, Association for Latino Professionals in Finance and Accounting (ALPFA), ASCEND, Golden Key International Honour Society, National Association for Black Accountants (NABA), Volunteer Income Tax Assistance (VITA), the Zicklin Graduate Tax Society, and Baruch College's own STARR Career Development Center. The events featured experienced professionals from accounting, finance, information technology, and marketing firms of all sizes. Students listened to and networked with speakers from Ernst & Young, IBM, Credit Suisse, KPMG, Berdon LLP, Morgan Stanley, UBS, J.P. Morgan, Deloitte, PricewaterhouseCoopers, and RAPP who spoke about industry trends, internship opportunities, interview tips, and career advice. 


March 18, 2010 - IBM: Contemplating on a Career in Accounting


April 8, 2010 - Psychology Behind Networking


