### SUMMARY OF TRINITY UNIVERSITY HISTORY






Located in the culturally rich city of San Antonio, Trinity University is one of the nation's top private universities. With 2,600 talented undergraduate and graduate students, the University is known for its stimulating, resourceful, and collaborative environment - in the classroom, on campus, and around the world.

The history of Trinity University is rooted in the vision of a few hardy Texas pioneers who believed in the transforming power of higher education. Despite an unfavorable economic environment and unstable political conditions, they aspired to establish "a University of the highest order" shortly after the conclusion of the Civil War. Founded in 1869, Trinity's name reflects its Christian origins and the three regional Cumberland Presbyterian governing bodies that supported its institutional organization. Over the past 140 years, Trinity has occupied three different Texas settings: Tehuacana (1869-1902), Waxahachie (1902-1942), and San Antonio (1942-present). Including the Woodlawn campus, which Trinity occupied from 1942 to 1952, the University has resided on four campuses in three different locations.

### Tehuacana: Foundational Challenges (1869-1902)

Trinity commenced classes on September 23, 1869 funded by contributions valued at \$30,000 consisting primarily of underdeveloped land and a few houses.


Despite recognition as a "Class A University" in Texas, sacrificial efforts by trustees, faculty, and staff were not sufficient to overcome a chronic lack of financial resources. By the end of the century, enrollment had dramatically declined. The only options were to close or to relocate.



### Waxahachie: Relocation and Renewal (1902-1942)

Seeking access to greater financial and cultural resources, Trinity moved 75 miles to Waxahachie, a railroad hub and cotton-farming community.

- Faculty strengthened Denominational contacts enabled Trinity to secure credentialed college and university graduates who brought diversity and expertise to the growing faculty.
- Reputation enhanced During the same time period, the National Council on Education included Trinity with only four other Texas institutions on its list of accredited colleges.
- Trinity accredited by the Southern Association of Colleges and Secondary Schools (SACS) in 1925.



The Woodlawn Campus (1942-1952)

On December 8, 1941, as the country entered into World War II, Trinity accepted an invitation from the San Antonio Chamber of Commerce to establish a strong Protestant institution of higher learning in the Alamo city. San Antonio business leaders promised financial support and facilitated a merger of Trinity and the University of San Antonio, a small Methodist institution, to provide temporary campus facilities.



By 1950 enrollment reached 2,000 and was composed largely of returning veterans and other San Antonio area residents.

#### The Skyline Campus (1952-1979)

Trinity had one more moving day before settling in its present location. On May 13, 1952, students, faculty, and community volunteers, including professional movers, transferred University property to the present site, a 107-acre hill top location with a commanding view of downtown San Antonio (Trinity acquired 10 acres adjacent to the south of campus to develop the recreational areas in the mid 1980's). On moving day the new campus consisted of a dormitory housing 60 residents, a classroom building that lacked a heating system, a barren library, an uncompleted student union, and a woman's dormitory under



construction.

By 1970, 42 new buildings had been erected, including the distinctive tower and chapel that quickly became campus landmarks.

Today Trinity University is a place of beauty, characterized by rigorous academics, distinguished faculty, superior facilities, and some of the most modern and impressive resources in the country. *U.S. News and World Repor*t has ranked Trinity #1 in the West among colleges offering undergraduate and master's degrees for nearly two decades.

## DEPARTMENT OF BUSINESS ADMINISTRATION/ ECONOMICS

Trinity University has both a Department of Business Administration and a Department of Economics. Business majors wishing to earn a Bachelor of Science degree must complete a core curriculum consisting of 27 semester hours as well as at least 12 hours in a certain concentration and enough extra hours to bring the total number of hours in BA courses to 45 hours. The core Business curriculum consists of introductory and mid-level courses in accounting, economics, management, finance, information systems, and marketing. Additionally, all Business majors must complete a 4000-level course in "Business Policy and Strategy" that fulfills the "Senior Experience" requirement of the University's common curriculum. Students pursuing a Bachelor of Arts degree complete the same 27 hour core curriculum with six hours of additional electives. The number of students currently studying Business at Trinity is as follows:




According to the registrar, there are 98 sophomores, 147 juniors, and 194 seniors who have declared Business Administration as their majors. The remainder consists of students pursuing minors or secondary majors in Business Admin.



Students seeking a degree in Economics may choose among six separate curricula: General Economics, Concentration in Theoretical Economics, Concentration in Economics and Law, Concentration in Economics and Business, Concentration in International Economics, or a concentration in Economics and Public Policy. These programs all require a total of 30 credits with the exceptions of the International Economics and Economics and Public Policy concentrations, which both require students to complete 33 semester hours. All Economics majors are also required to complete a Senior Experience course that consists of five options including seminar, capstone, and thesis courses. Students with at least a 3.5 gpa in Economics who receive approval by a majority of the department faculty are also eligible to earn an


"Honors" degree with the completion of an honors thesis. As of this school year, there are 121 Economics majors at Trinity: 21 sophomores, 48 juniors, and 52 senior students.



### COLONY DEVELOPMENT

Since the colony started in the fall of 2009, we have completed various events to benefit not only our members, but also the Trinity University campus as well as the San Antonio community at large. These included professional events, service events, fundraisers, and social events for our members.

Our colony planned diverse professional events, taking advantage of not only resources and speakers from within the Trinity University community, but also from outside. Resources on campus such as Career Services, the debate team sponsor,



and Counseling Services gave presentations about goal setting, resume design, time management, and business arguments. We also sponsored an event open to the entire Trinity University community called "Dress to Impress" which our members organized that explained the proper attire for different business situations. Additionally, we partnered with Kaplan to put on two different information sessions about the GMAT and applying to grad school, as well as a partnership with the VITA (Volunteer Income Tax Assistance) Program.

The colony also put on several community service events. Two events included collecting canned food and clothing for victims of disasters that had recently occurred. Our canned food drive was done in cooperation with the University of Texas San Antonio chapter, and many of our members were able to interact with Omicron Phi members for the first time.




Several times we had events at assisted living facilities in the San Antonio area where our members did activities that included talking and playing games with the residents and serving food and drinks. Our final service event of the

academic year was cosponsoring GIVE day with several other Trinity University organizations, where participants were divided into groups and did a number of different volunteering activities, such as going to SAMs home to play with the children, working on Habitat for Humanity projects, and picking up trash at local parks.



Our fundraising activity included soliciting donations from businesses and setting up "nights" at restaurants in the area which our colony would receive a percentage of the sales. We encouraged members to attend these as both a means to raise money for the colony and a social event. We also had other social events during the year such as an ice cream social in the fall and a spring pool party.






















### MEMBERSHIP STATISTICS
