The Founding

Chapman University, currently located in Orange, California, was founded as Hesperian College in 1861 in Woodland, California by members of the Christian Church (Disciples of Christ). The school has always admitted both men and women of all races which, at one time, was a radical educational concept. The school changed its name to Chapman College in 1934 after receiving a sizeable donation from local entrepreneur Charles Clarke Chapman, also known as the "Orange King of California". By 1954, the school had moved to the former campus of Orange Union High School in Orange, California where it remains today. Chapman College officially became Chapman University in 1991, the same year James L. Doti took over as President.

Major Development & Growth Events

Since its founding, Chapman has grown into a highly regarded university that attracts high-achieving undergraduate and graduate students from all over the United States and more than 60 nations around the world. Chapman has continually increased both its physical size (student population and campus size) and its educational opportunities. In fact, the campus has more than doubled in size in the past ten years alone following an aggressive expansion plan. This plan began in 1998 with the establishment of Beckman Hall which now houses the Argyros School of Business and Economics. Chapman is now the largest private university in Orange County and continues to pride itself on its highly personalized education despite its ever-growing student population. The school has forever maintained a 14-1 student to teacher ratio even though enrollment is at an all-time high. Chapman University is quickly becoming the class of liberal arts universities and was recently ranked the #6 college in the western region by *U.S. News and World Report*.

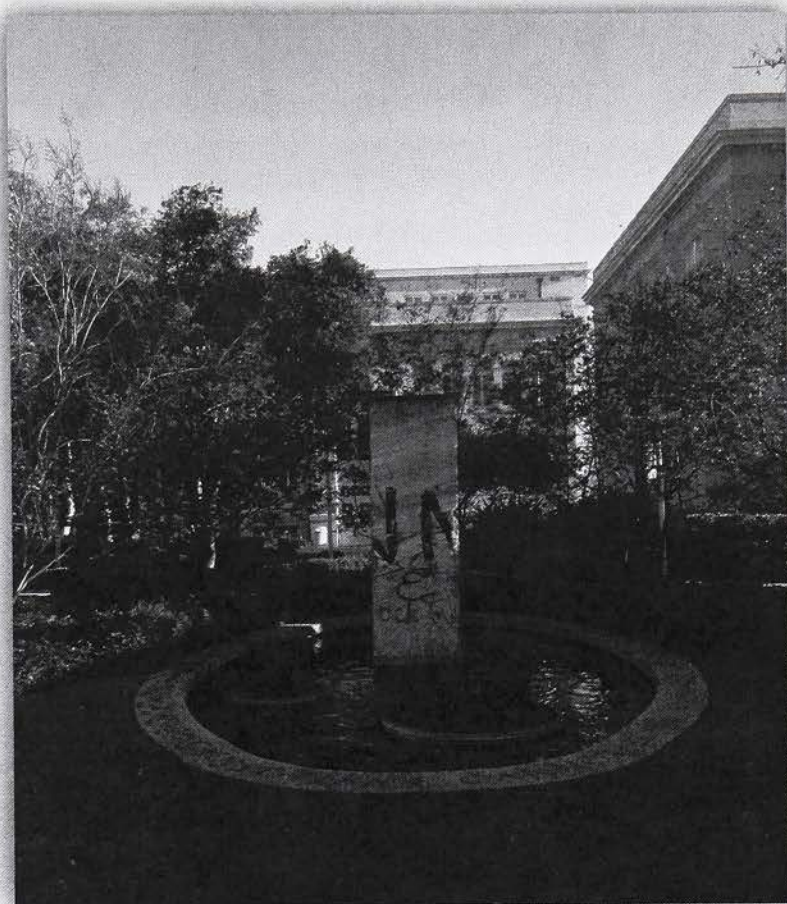

Section IV

History of the Department

HISTORY

Chapman University was established in 1861 as a Hesperian College.

In 1977, the Chapman Business School was founded. The Arnold and Mable Beckman Business and Technology Hall, where the majority of ASBE classes are taught, was built in 1998. A year later, the school was renamed after George Argyros, a Chapman University alumni and former U.S. Ambassador to Spain. He served as Chairman of the Board of Trustees of Chapman from 1976 to 2001, and he is currently still on the Chapman Board. ASBE is one of only 560 other schools to be accredited by the Association to Advance Collegiate Schools of Business. The faculty of ASBE is vast: there are 131 professors, of which includes various numbers of permanent faculty, assistant professors, and adjunct professors.

The Argyros School of Business and Economics offers three majors and two minors. Students can receive a Bachelors of Science in Business Administration, Bachelors of Science in Accounting, or Bachelors of Art in Economics. The two minors offered are Minors in Business Administration and Economics. There is also a Masters in Business Administration (MBA) for post-grad students, as well as a 5-year MBA program for undergraduate students to continue one additional year of schooling to receive the MBA degree. There are more than 1,200 undergraduates enrolled in ASBE as the business school is one of the more popular schools on campus.

In 2009, ASBE's own career center was created. The Office of Career Planning and Placement focuses on the students within the school, and provides programs and services for undergraduate business, accounting, and economic students, and assists students in obtaining internships with various companies and firms by developing business relationships with local and national employers. The recruitment program put on specifically for accounting students and firms is especially comprehensive, competitive, and successful.

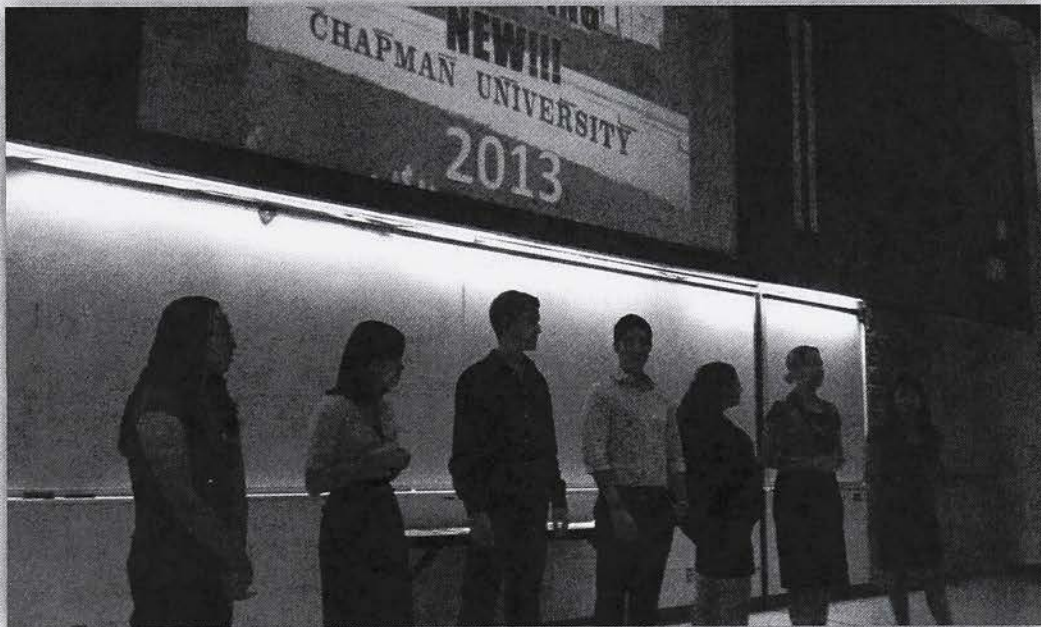

Lauren Hanson



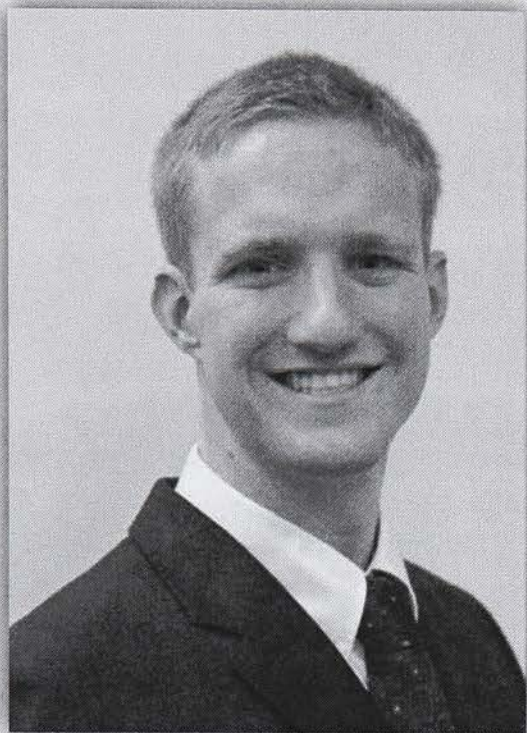

Laura Johnson



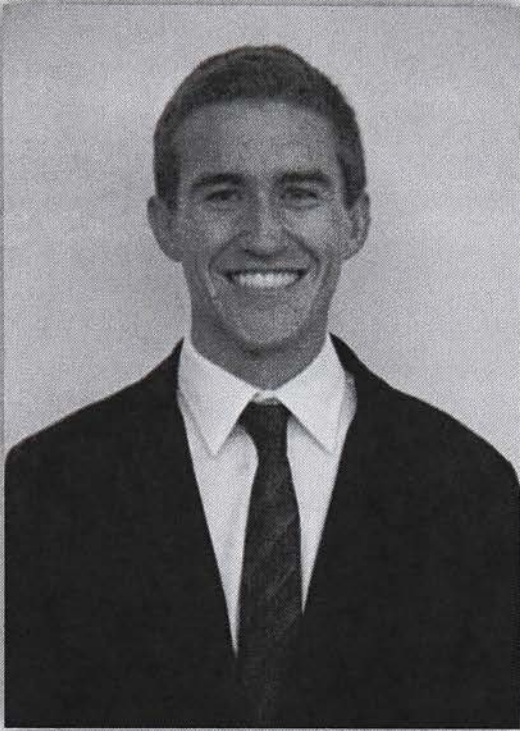

Kelsey Kasumi



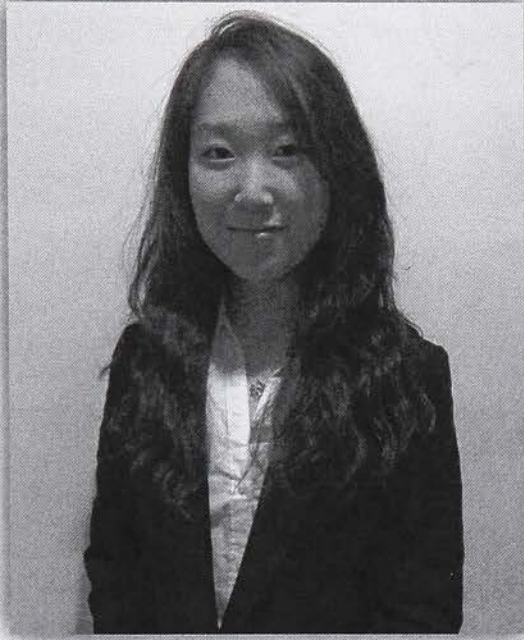

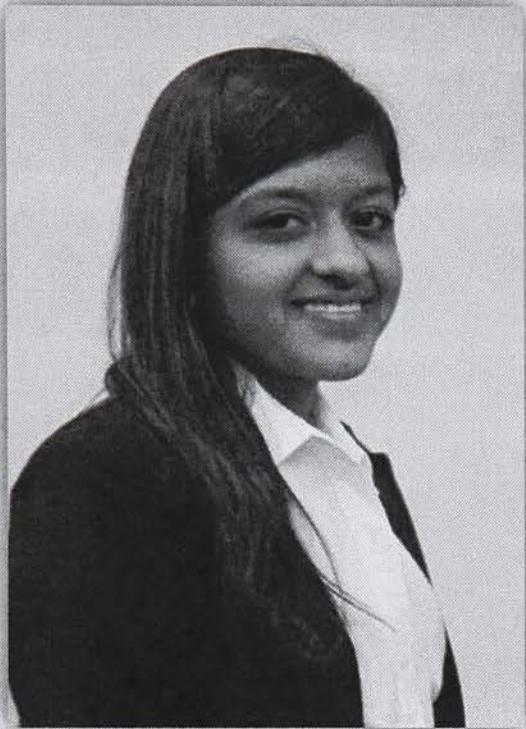

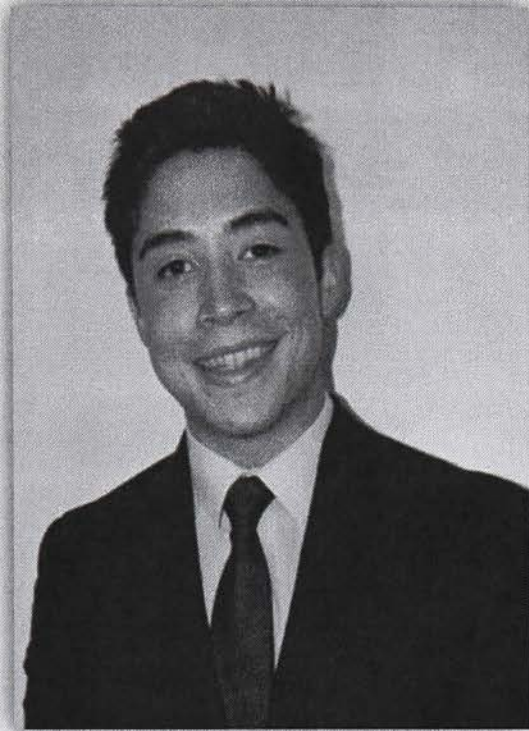
only did she acquire the most community service hours at her high school but she was also awarded the Rotary of Scott's Valley's Most Outstanding Community Service Award.

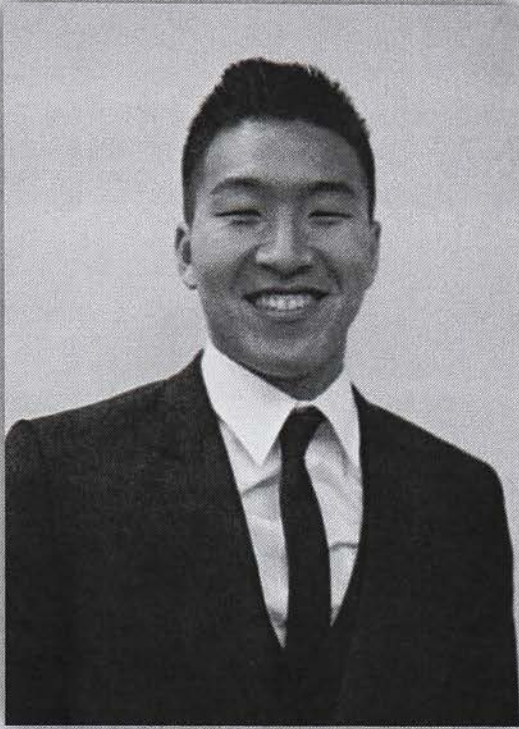

in her senior year.

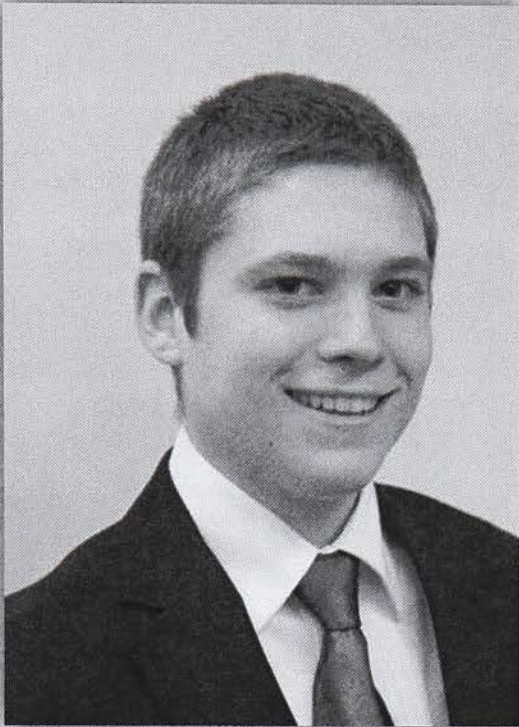

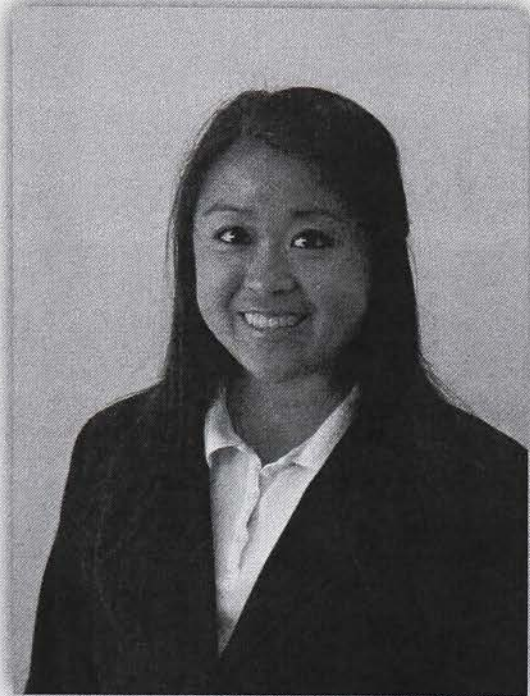

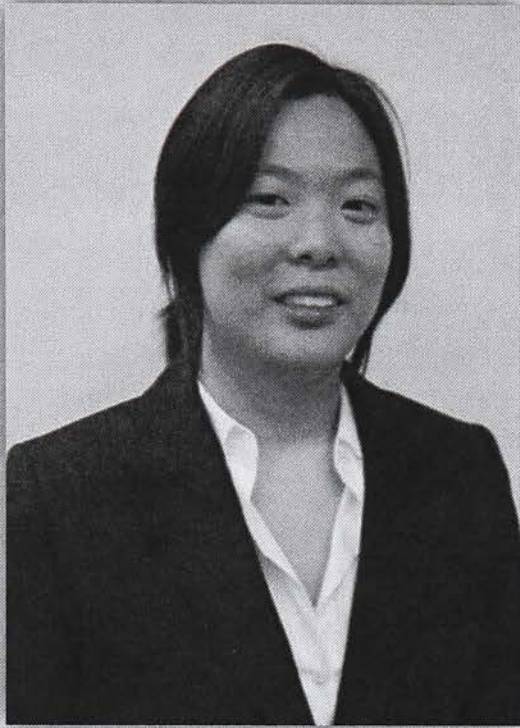
much greater than herself.
