#### **Discipline and Chapter Assistance**

Kappa Xi – Kappa Xi continues guidance at this time. They continue to struggle but have made improvements in many areas. The chapter has worked closely with their local leadership which has helped with this improvement and continues to be receptive to assistance.

Eta Tau- Leadership is working with this chapter and feels that continued close involvement is needed. The chapter is benefiting from involvement as indicated by the strong response to completing needed requirements on time and keeping in contact with leaders.

Eta Nu – Eta Nu continues guidance. The local leadership team is active with this chapter and is looking to build a team to provide additional support needed assistance.

Lambda Upsilon-Lambda Upsilon continues on probation due to hazing violations of both Delta Sigma Pi and St Mary's University. The University probation will be reviewed by 12/31/2016 with fraternity probation continuing until 6/1/2017. The chapter has completed many of the requirements for probation including

professional activities regarding hazing and submitted a communication plan that has been submitted to both Fraternity and University leadership.

Beta Phi – Recently it was identified that the Beta Phi chapter had multiple violations including to charge pledges excessive fees above that allowed in the standard pledge education process, use of unapproved ritual and lack of communication with leadership. During their last meeting, the Board of Directors approved a twelve month probation.

#### **Board Project Update**

#### **Board Communication Tool**

The HUB has been updated with a field that allows for the board to provide feedback to other board members and stakeholders. While there was slow adoption to use the new fields, there was an increase in usage in the week leading up to the last board meeting. Issues for improvement were identified including more frequent emails for updates and to include the last comments made. Future updates may also include online voting.

### **Summary**

The last year has been successful and the province will end on a strong note. Highlights include continued growth in membership along with the recent addition of a colony at the University of Texas at Dallas. We have also continued our commitment to future Brothers by moving \$2,671.92 to our Provincial Travel Fund. On the other side we have had significant rise in discipline issues at both the member and chapter levels including several cases of chapter hazing, national bylaws and policy violations. Leadership is working with chapters but a renewed focus on education will be recommended going forward and into the next biennium.

#### Eta Nu – University of Missouri - St. Louis

Eta Nu has faced challenges in the past but is slowly improving chapter success despite not having district director assigned currently. They are currently under guidance because of pledge dropout rates. The pledging program will be under closer supervision during the spring semester to improve performance in this area.

#### Eta Sigma – Southern Illinois University - Edwardsville

Eta Sigma is a consistent chapter with good regional involvement. They have taken steps toward hosting joint events with other chapters in the Gateway region. They have good programming and strong chapter brotherhood. They are in good position for CMP Accredited status with a strong possibility of Recognition status.

#### **Iota Nu – Truman State University**

Iota Nu is a strong chapter with good event programming. Many brothers are leaders on campus and within other organizations. The chapter has a strong history and is in a good position for continued success. The chapter is in a good position for CMP Accredited and Recognition status. They are on target to also achieve CMP Excellence status.

#### Kappa Omicron – Missouri State University

Kappa Omicron is a good chapter with strong brotherhood and good event programming. The chapter is on target to achieve CMP Accredited status.

#### Sigma Psi – Lindenwood University

Sigma Psi has strong brotherhood and is involved within the university. They are successfully growing. The chapter is on target for CMP Accredited status.

#### Chapter Updates (as of 12/20/2016)

- Beta Psi Louisiana Tech University (LA Tech) Ruston, LA
  - CMP-Accredited Chapter: Complete 43.90% Approved 39.02%
  - Beta Psi had six Brothers registered who attended LEAD in Jacksonville, and they have registered for Houston South Central LEAD Provincial. As the only Gulf South Regional Chapter functioning on the Quarter System, they continue to exhibit the enthusiasm and positive attitude to remain successful. The Chapter embraces an energetic can-do attitude and has successfully maintained pride and enthusiasm, winning every award they applied for last year.
- Beta Zeta Louisiana State University (LSU) Baton Rouge, LA
  - CMP-Accredited Chapter: Complete 48.78% Approved 43.90%

• As the largest chapter in the Gulf South Region, they consistently have representation at National Events, including nine at Denver LEAD this fall. As of December 20, Beta Zeta has not registered for Provincial LEAD, but they are planning to have a seated delegate. They incorporate a wide array of professional, community service, and social events, eliciting great responses and participation from collegiate brothers and alumni. Beta Zeta does not just aim to meet expectations but is intent on exceeding them.

#### • Delta Nu – Loyola University – New Orleans, LA

- CMP-Accredited Chapter: Complete 48.78% Approved 39.02%
- Delta Nu has experienced vast improvements in all areas of CMP. They had no representation at Fall LEAD but plan on sending a delegate to Provincial. Communication with leadership is not as strong as the previous semester; however, they do make every effort to share info. Opportunities for joint events and activities in conjunction with neighbor Gamma Mu are being discussed. They have a new District Director who is anxious to help them succeed.

## • Eta Tau – McNeese State University – Lake Charles, LA

- CMP-Accredited Chapter: Complete 53.66% Approved 46.34%
- Eta Tau has had problems in many aspects of CMP and is on CMP Guidance until August 13, 2017. They are making steady progress towards improvements. They had representation at Jacksonville LEAD (one collegian), and they are planning to send a delegate to Provincial, although they have not as yet registered. They have an experienced DD (an Eta Tau Alum) who is an excellent resource for information and to answer questions.

#### • Gamma Mu – Tulane University – New Orleans, LA

- CMP-Accredited Chapter: Complete 36.59% Approved 21.95%
- Gamma Mu is gradually improving, however, they were unable to send representation to fall LEAD but have every intention of going to Provincial. One big hurdle to overcome is their lack of an alumni base to rely on (Gamma Mu initially deactivated in the 1960s). They are making sincere efforts to build one from scratch with the last couple of graduating classes. It is a slow process, but they are eager to succeed. More communication with their DD and RVP would be beneficial and prevent "trial and error" situations. Alpha Kappa Psi has that ever present foothold at Tulane University, and practically every professor in the School of Business is a member. Gamma Mu has strong leadership in their DD, and they are encouraged to connect with Delta Nu, which is literally next door. A partnership with hosting and attending events would be beneficial to both Chapters.

#### • Kappa Xi – University of Louisiana at Lafayette (ULL) – Lafayette, LA

- CMP-Accredited Chapter: Complete 39.02% Approved 26.83%
- Kappa Xi's CMP Guidance was extended until December 31, 2016, and they have made small improvements in some areas but reverted in others. They did have four collegians represent the Chapter at fall LEAD in Denver and will seat a delegate at Provincial. Kappa Xi has a DD who is an alum of the Chapter and has done much to help them return to functionality. Kappa Xi is continuing attempts at securing sponsors and developing creative ways to fundraise.

#### **Regional Expansion Activity**

Consideration has been given to the feasibility of an Alumni Chapter in Ruston, LA (LA Tech).

#### **Regional Goals For 2016/2017**

These goals are inclusive for Chapter Officers/Members and Leadership (RVP, DDs, etc.):

- 1) Promote stronger attendance at National Events LEAD, Provincial, GCC
- 2) Stress a more conscientious effort to comply with deadlines CMP, Awards, etc. and encourage early registrations for National Events
- 3) Encourage and ensure chapters maintain a clear line of communication with leadership and alumni
- 4) Encourage chapters to achieve Accredited Chapter status and beyond
- 5) Continue to encourage communication/interaction/brotherhood among Chapters

#### **Suggestions and Comments**

Two Gulf South Chapters were on CMP Guidance for the fall semester –

- Eta Tau until August 13, 2017 Although a strong improvement is noted with regard to meeting deadlines and completing tasks, I suggest Eta Tau continue as planned on Guidance until the completion date. Having more structure can only assist with their continued improvement and help them be more conscientious with regard to time management, communication, commitment and responsibility.
- Kappa Xi until December 31, 2016 Kappa Xi has improved in some areas but dropped in others. I am torn with which direction to pursue. On one hand, if there is a possibility Guidance could continue until August, they may have a much better chance of continued improvement and maintaining balance. On the other hand, or if continuance is not an option, the vote of confidence in removing them from Guidance could boost morale and encourage them to strive harder for improvement. They have been on some type of discipline for two years, and I would hate to see them become disillusioned and/or defeated.

Time management and deadlines are always a big problem for many of the Chapters. I realize the significance for having deadlines at the end of semesters, however, when Chapters have Initiations in mid to late November, elect new officers shortly thereafter, immediately jump into finals, followed by end of semester-pack up to go home, things such as a December 15<sup>th</sup> deadline are difficult to maneuver. I, and the DDs, spend countless hours emailing, texting, and calling in reminders and follow-ups. It is worth every second, though, to watch these collegians step up to the plate, accept the challenge and complete their tasks with pride and without complaint!

CMP Report - Complete 36.59% | Approved 29.27%

#### Texas A&M University -Kingsville

CMP Report – Complete 48.78% | Approved 43.90%

Zeta Nu did a fantastic job recruiting this last semester. They have strong programming and relations with the university. They should co-host and join chapter events with TAMUC since they are a sister chapter less than an hour away. They should also encourage the significant amount of alumni in the city to form an Alumni chapter to further support their chapter goals.

#### Eta Psi

#### **University of Houston**

CMP Report – Complete 51.22% | 43.90%

Eta Psi had a rocky start with the university and past president but have quickly overcome all obstacles and well on their way to chapter of recognition or excellence. They have some of the strongest alumni support and they need to continue solid transitioning to keep this sustained growth.

#### **Theta Omega**

#### St. Edwards University

CMP Report – Complete 53.66% | 48.78%

Theta Omega has solid fraternal spirit. Their turnaround has been amazing since they are now turning all critical reports on time. They should continue to concentrate on chapter professionalism and member growth.

#### **Iota Psi**

#### Texas A&M University - Corpus Christi

CMP Report – Complete 68.29% | 63.41%

Iota Psi has great fraternal spirit and well on their way to Chapter of Recognition and Excellence. They have great programming and solid support from the Corpus Christi Alumni Chapter. They need to concentrate on having events with their sister school TAMUK that is less than an hour away and building a stronger alumni relationship.

#### Lambda Nu

#### **Texas A&M University**

CMP Report – Complete 51.22% | 43.90%

Lambda Nu has strong operations across the board and continues to engage well in regional activities. They can benefit by taking advantage of this situation and developing a continued relationship with the rest of the region.

#### Lambda Upsilon

#### St. Mary's University

CMP Report – Complete 39.02% | 26.83%

Lambda Upsilon has successfully removed them out of university suspension to chapter probation for the semester. With strong leadership their fraternal bond has grown from this ordeal and they continue to push for chapter recovery and growth.

#### **Omicron Phi**

#### University of Texas at San Antonio

CMP Report – Complete 60.98% | 53.66%

The chapter has great fraternal spirit and communicates daily on their group page. Reports show strong programming and operations. They could benefit to network a bit more with the other San Antonio chapters such as Lambda Upsilon and Pi Omega. They are encouraged to continue building their relationship with the alumni chapter.

#### Pi Omega

#### **Trinity University**

CMP Report - Complete 51.22% | 46.34%

Pi Omega has had a great turnaround regarding fraternal spirit and regional involvement. I encourage them to reach out and build their network with the San Antonio alumni chapter. They are hosting the GWR Regional conference this year.

#### **Regional Expansion Activity**

We were looking at expanding the region and including four universities; Texas State University, University of Houston – Victoria, University of the Incarnate Word, and The University of Texas – RioGrande Valley. Victoria is no longer an option due to the entire business school. We have several discussions moving to an online curriculum. Several meetings are scheduled to introduce the Fraternity to these schools.

#### Regional Update for 2016-2017

The Gulf Western Region continues to do well overall. We have seen an increase in inter-chapter communication and participation over the years. Regional event planning has been a tremendous influence in increasing morale, fraternal spirit, and CMP credit. All District Directors have been empowered to make the right decisions in accordance to bylaws, policies, and risk management. Most DDs are well on their way to obtaining CDL tiers 1 and 2.

The San Antonio alumni chapter and Corpus Christi alumni chapters have been doing extremely well. The San Antonio Alumni Chapter has three members that are District Directors in the region for UTSA, Trinity and St. Mary's University. The Corpus Christi Alumni chapter has a member as a District Director for TAMUCC. The CC Alumni chapter earned a Gold Status and the SA Alumni chapter earned a Silver status last year. The Austin Alumni chapter is fairly new yet taking great strides to reach Gold status this upcoming year.

The leadership team has implemented better communication methods via Facebook and GroupMe to communicate with all chapters. The region is looking to host its own leadership conference as a means to raise fraternal spirit, increase our networking opportunities, and increase alumni participation. This coming semester's Spring Initiation will be hosted by the Omicron Phi chapter of The university of Texas – San Antonio.

#### **Chapter Updates**

Overall, chapters in the Tornado Alley Region are doing OUTSTANDING!

#### Beta Epsilon - University of Oklahoma

- CMP {56.10% Complete; 51.22% Approved} Chapter is on track for Chapter of Excellence.
- The chapter's professional activities mainly consists of speakers at meetings. They have done several beneficial community service events this past semester, including their annual Price Day of Service.
- The chapter has done a really unique brotherhood retreat the past two years, where they spend a weekend at a church camp on Lake Texhoma and focus on brotherhood and our Principles. The discussions and speakers (usually chapter members) have been outstanding and a great experience.
- One of the chapter's main focus going forward in 2017 is brotherhood within the chapter and exec team. The chapter has already done some things to take the lead on this and make improvements.
- An area of improvement for the chapter can be the trial rate, which was very high in 2016. However, there were very few expulsions in comparison. A review of policies could possibly help reduce this rate.
- Chapter is a Legacy Chapter.
- There are no chapter discipline issues to note.

#### Beta Upsilon - Texas Tech University

- CMP {68.29% Complete; 65.85% Approved} Chapter is on track for Chapter of Recognition.
- The chapter had 17 brothers at Denver LEAD, which was the most at a LEAD from the Tornado Alley Region.
- The chapter conducted a joint community service event with the Alpha Kappa Psi chapter at Tech, where they had a competitive food drive. Delta Sigma Pi won the competition and both chapters helped the community.
- The chapter has made some good strides operationally over the past semester and will continue to make improvements in this area.
- The chapter continues to see strong recruitment ability, compared to the Alpha Kappa Psi chapter, and pledge retention rates continue to be high (100% for fall 2016).
- Chapter is a Legacy Chapter.
- There are no chapter discipline issues to note. Past issues appear to be corrected, which is a positive testament to the attitude of the chapter members.

#### Gamma Epsilon – Oklahoma State University

- CMP {51.22% Complete; 43.90% Approved} Chapter is on track for Chapter of Excellence.
- This chapter continues to make amazing improvements operationally from where they were a couple years ago.

- The chapter held a Cowboys Strong Run, a follow up to last year's Homecoming Memorial Run. They netted about \$7,500 from the event, which was donated. They are already working on next year's event.
- The chapter won the National Financial Operation Award this past semester, and they continue to have outstanding financial operations.
- One of the chapter's goals going into 2017 is to have better relations between exec and other members, as well as to continue to recruit high quality members. Fall 2016 was one of their strongest recruiting sessions from the last couple years and they are hoping to build on that.
- The chapter had a pledge retreat for the first time this semester, which might have helped with the pledge retention issues of past semesters.
- Chapter is a Legacy Chapter.
- There are no chapter discipline issues to note.

# **Epsilon Zeta – Midwestern State University**

- CMP {56.10% Complete; 43.90% Approved} Chapter is on track for Chapter of Excellence.
- Overall the chapter has improved operationally since last year. The current exec brings a healthy attitude and passion to the chapter.
- The chapter has done several professional and community service events this past semester. They are planning a large semester long community service event with Sigma Chi that will benefit the food banks of Wichita Falls, TX and Lawton, OK.
- The chapter had much better recruitment and pledge retention this past semester. If they can continue what they did they can bring their chapter numbers up to a healthy level within the next year. Being a small school, the chapter will need to always focus on recruitment efforts.
- Chapter is a Legacy Chapter.
- There are no chapter discipline issues to note.

#### Sigma Chi - Cameron University

- CMP {56.10% Complete; 43.90% Approved} Chapter is on track for Chapter of Excellence.
- The chapter has done several professional and community service events this past semester, including joint events with other organizations. They are planning a large semester long community service event with Epsilon Zeta that will benefit the food banks of Wichita Falls, TX and Lawton, OK.
- Like other small schools, the chapter continues to struggle with recruitment. Cameron has a very unique student base. Recruitment will be a continued area of emphasis and the chapter is creating plans to improve this in the future.
- Although the chapter is fairly new, they have been able to have pretty good alumni and faculty relations and hosts an annual alumni softball game.
- Chapter is a Legacy Chapter.
- There are no chapter discipline issues to note.

#### Oklahoma City Tornado Alley Alumni Chapter

- Chapter is doing awesome!
- The chapter was awarded Gold Recognition for the past year and is on track to repeat this year. The chapter also won the Provincial award for Community Service.
- Attendance at national events has been higher than previous years and several are registered for Houston LEAD and GCC.
- Attendance at major events has increased from years past.
- The chapter has done several things to support collegiate chapters in the region, including chapter visits, support of the STAR Retreat, and upcoming grants to each chapter to help with GCC expenses.

## **Regional Expansion Activity**

There has been no expansion activity in the region over the past year. There are a few possibilities over the next couple of years for new colonies, including University of Tulsa, West Texas A&M, University of Central Oklahoma, and University of Arkansas. These opportunities will most likely be available due to brothers transferring and helping establish a colony. No attempts have been made at University of Arkansas since 2013, when issues arose during discussion with the Dean of the Business School.

Ongoing effort is being made to expand alumni chapters in the region. Currently, Oklahoma City Tornado Alley Alumni Chapter is the only franchised alumni chapter, after Tulsa and Wichita Falls elected not to refranchise in June 2016. Effort is being made to refranchise Tulsa and Wichita Falls, as well as a new one in Lawton. It is also being explored if it is possible to have one alumni chapter that covers Wichita Falls and Lawton.

#### **RVP/Regional Goals For 2016/2017**

- 1. Be the voice of the collegiate and alumni brothers in the region based on their input Continue to get feedback from collegiate and alumni brothers and pass along the information as appropriate.
- 2. Have quality Chapter COYs and 100% application submission COY was taken to a new level this year. Starting in 2015, an emphasis was made to educate brothers on what COY is and what they should consider when selecting COYs. Most chapters followed a process consisting of week 1 educate members about COY, week 2 nominate members for COY, week 3 nominees give speeches and chapters vote. This resulted in competitive races within chapters and winners taking their applications seriously. Most, if not all, winners reached out to current and past National COYs for advice and guidance and the region saw 100% application submission for the first time ever.
- 3. Encourage Bucks for Brotherhood to help the South Central Province have highest participation We encouraged chapters to get their \$100 donation for CMP out of the way for Bucks for Brotherhood and saw all 6 chapters participate for the first time ever. Tornado Alley Region had more chapters participate than any other region in the country.
- 4. Encourage and promote inter-chapter events Ongoing. Several chapters over the past year have done joint socials, initiations, and community service events. Some joint events are already planned for the

- future. Will continue to encourage all chapters to participate in things and for chapters to reach out to chapters in other regions as well.
- 5. Encourage and promote attendance at National and Regional events Ongoing. Attendance at national events has increased recently. Use of personalized electronic invites and extensive social media has helped bring awareness to attend. Other promotional tools included chapter attendance awards for attending Provincial LEADs. Chapters have also helped members financially, in order help increase attendance. For Grand Chapter Congress, we have been selling state pins with our letters on them to raise funds. As a result, each chapter in the region will get a \$100 travel grant to GCC from OKCTAA.
- 6. Provide the tools necessary for chapters and colonies to be successful Ongoing training and resources.
- 7. Encourage chapters to apply for awards Ongoing. 2016-2017 is to be determined. In June 2016, Tornado Alley chapters submitted more award applications than any other region in the South Central Province. OKCTAA won a provincial award and Gamma Epsilon won a National award. Hoping to see the same or better in 2017.
- 8. Encourage chapters to reach Chapter of Excellence tier for CMP Ongoing. Starting last year, we created an incentive for chapters to do well in CMP: Chapter of Recognition would be awarded a congratulatory cake at a chapter meeting and Chapter of Excellence would be awarded the cake and a \$100 grant. Last year, 3 chapters received Chapter of Excellence and 1 chapter received Accredited Chapter. Hoping to see the same or better in 2017.
- 9. Identify and develop potential alumni leaders in the region Ongoing. Continue to seek out quality potential alumni leaders and encourage them to remain active. We have started making it a point to talk about volunteer work as an Alum and how we have gotten in the positions we are.
- 10. Work with collegiate and alumni chapters to help develop a smoother transition for graduating seniors to the alumni world Work in progress. We continue to see the same struggles as the rest of the country. We have started contacting alumni chapters in the areas new graduates are moving to in order to try to help with alumni chapter recruitment. We also invite every single collegiate brother to the major alumni chapter events in the region, and make collegiate brothers aware of alumni events in other major nearby cities.
- 11. Promote and foster professional development in the region Ongoing. This is not at a level it could be. We continue to try to share job opportunities as they present themselves. Regional leadership shares ideas with chapters on expanding their professional programs. One specific goal has been to create a mentorship program. This has not happened at the time of this report for various reason. Hoping for a Beta test spring 2017. If successful, it might be better administered at a Provincial level. In addition, a couple of the collegiate chapters have taken the initiative and created an internship database to help with networking. Hoping to see this be successful.

#### Summarization of the Proposal/Recommendation.

Propose to amend the Election of Pledges bylaw to remove ambiguity.

The current rule limiting a prospective pledge to be rejected three times is vague, which leads to different chapters interpreting the rule to create very different vote-in procedures, including:

- An applicant can be proposed & rejected unlimited times in a given semester, but can only apply three semesters
- An applicant can be proposed & rejected up to three times regardless of number of semesters; if his name is proposed twice in one semester he can only apply in one later semester.

This proposal seeks to create consistency between chapters.

Current Bylaws Article XII. Section 11. "Election of Pledges":

Section 11. Election of Pledges --- Except as provided hereinafter, no person shall be initiated into this Fraternity except through a Collegiate Chapter and by a secret vote of the members of said chapter, in good standing, constituting a quorum present at a regularly called meeting as may be defined by the Bylaws of the chapter and the Laws of this Fraternity. All elections to pledgeship in this Fraternity shall be by secret ballot. To ensure against mistake, should twenty percent (20%) of the members present and voting, or five (5), whichever is greater, negative votes appear in the ballot box on the name of a prospective pledge, a second ballot shall be immediately taken. If twenty per cent (20%) of the members present and voting, or five (5), whichever is greater, negative votes appear in the ballot box on the second ballot, the prospective pledge shall be considered rejected. Before any ballot is cast, the ballot box, if used, shall be shown to the President, the Senior Vice President, and the Vice President-Chapter Operations, who shall severally vouch for the emptiness of the same. All qualified members of the chapter present shall vote. Failure to vote shall be construed as a favorable vote for the candidate. After all such members have voted, the ballot shall be declared closed, the same inspected, and the votes counted by the President, Senior Vice President and the Vice President-Chapter Operations. The declaration of these officers announcing the vote favorable or unfavorable to election shall be final. Should the name of the same prospective pledge be proposed and rejected a third time, the same prospective pledge shall never be proposed again in that chapter. The votes concerning prospective pledges described herein must be held before the individuals in question are formally accepted as pledges. Should the prospective pledge receive a favorable election, but be unable to accept pledgeship, an election must be held in any subsequent academic term in which the prospective pledge's name is proposed again.

#### Proposed Bylaw Article XII. Section 11. "Election of Pledges":

Section 11. Election of Pledges --- Except as provided hereinafter, no person shall be initiated into this Fraternity except through a Collegiate Chapter and by a secret vote of the members of said chapter, in good standing, constituting a quorum present at a regularly called meeting as may be defined by the Bylaws of the chapter and the Laws of this Fraternity. The declaration of these officers announcing the vote favorable or unfavorable to election shall be final. Should the name of the same prospective pledge be proposed and rejected a third time IN THREE SEPARATE PLEDGE CLASSES, the same prospective pledge shall never be proposed again in that chapter. The votes concerning prospective pledges described herein must be held before the individuals in question are formally accepted as pledges. Should the prospective pledge receive a favorable election, but be unable to accept pledgeship, an election must be held in any subsequent academic term in which the prospective pledge's name is proposed again.

#### Recommended implementation date and logic for selecting this date

August 2017, to coincide with start of new year after the next GCC.

#### Positive aspects of implementing Proposal/Recommendation

- Removes vagueness from current bylaw, allowing more uniformity in vote-in procedure
- Increases fairness to applicants by standardizing vote-in procedure
